## Recommendations

## Introduction to Nonlinear Functions

### Linear vs. Nonlinear Growth

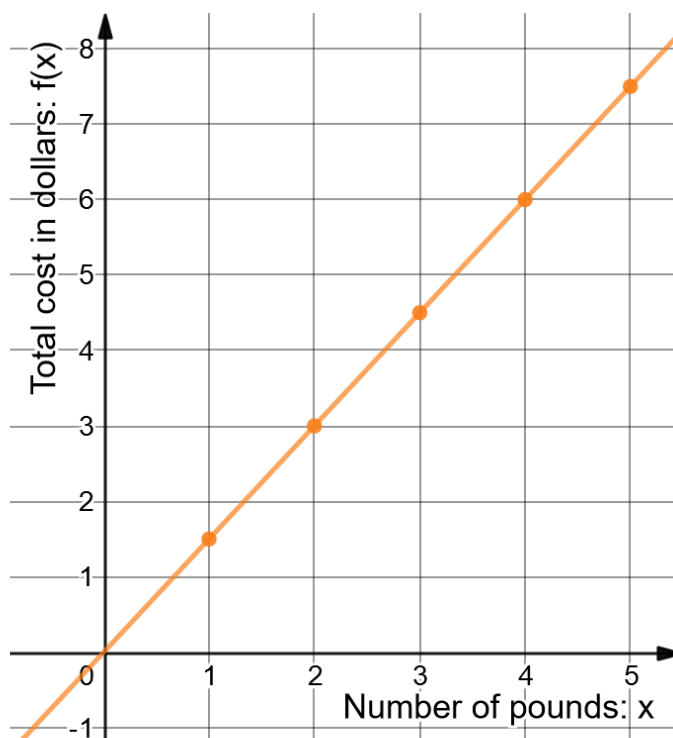
Functions are a way to understand how different quantities grow in relation to other quantities. Some quantities grow in a linear way. This means that the same amount is added on while the quantity grows. For example, the price of different amounts of oranges grows in a linear way. If 1 pound of oranges costs \$1.50, then 2 pounds costs \$3.00, 3 pounds cost \$4.50, and so on. For each additional pound, another \$1.50 is added on.

A function rule for the price of oranges might look like this:  $f(x) = 1.5x$ . The variable  $x$  represents the number of pounds of oranges and  $f(x)$  represents the total cost of  $x$  pounds of oranges.

We could also graph the price of oranges (shown on the right). Notice how a graph of the points makes a straight line? That's why  $f(x) = 1.5x$  is called a “linear” function.

Another way to write the function is with a linear equation,  $y = 1.5x$ . Both linear functions and linear equations make lines when inputs and outputs are plotted on a graph.<sup>1</sup>

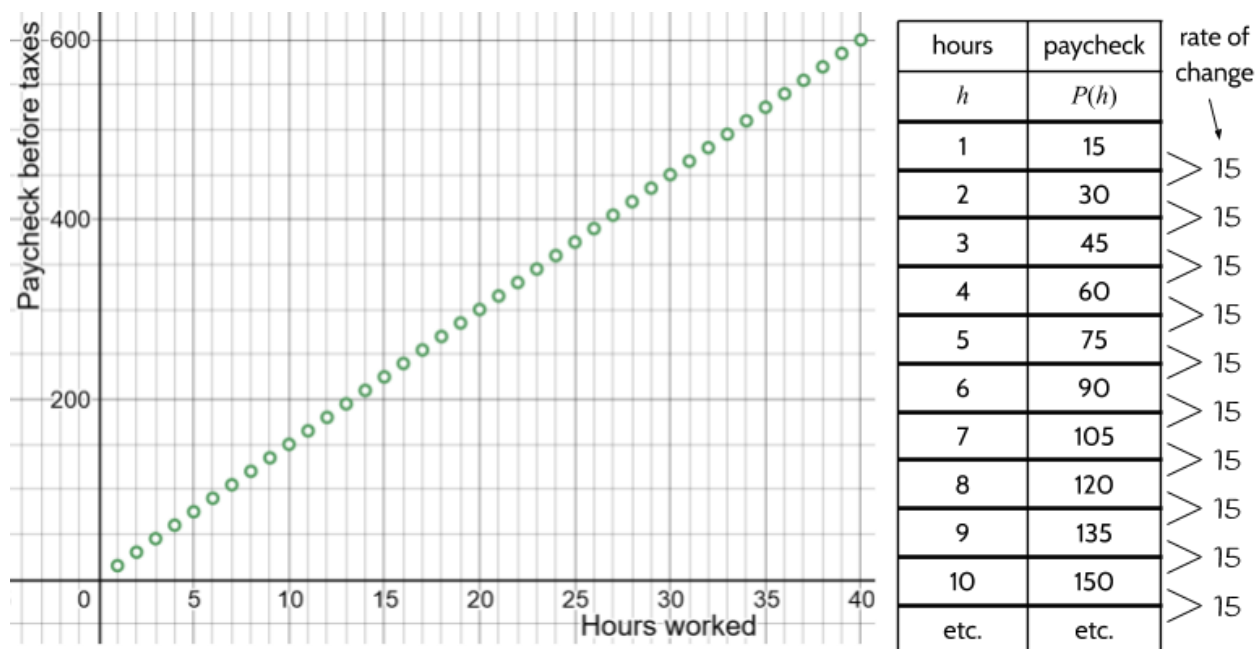

## Tools of Algebra: Nonlinear Functions (Part 1)

Another example of linear growth is the size of a paycheck based on an hourly wage. If you work for \$15.00/hr., the size of your paycheck before taxes is 15 multiplied by the number of hours. The rate of change of 15 would be constant, since you add \$15.00 to the paycheck for each additional hour of work..



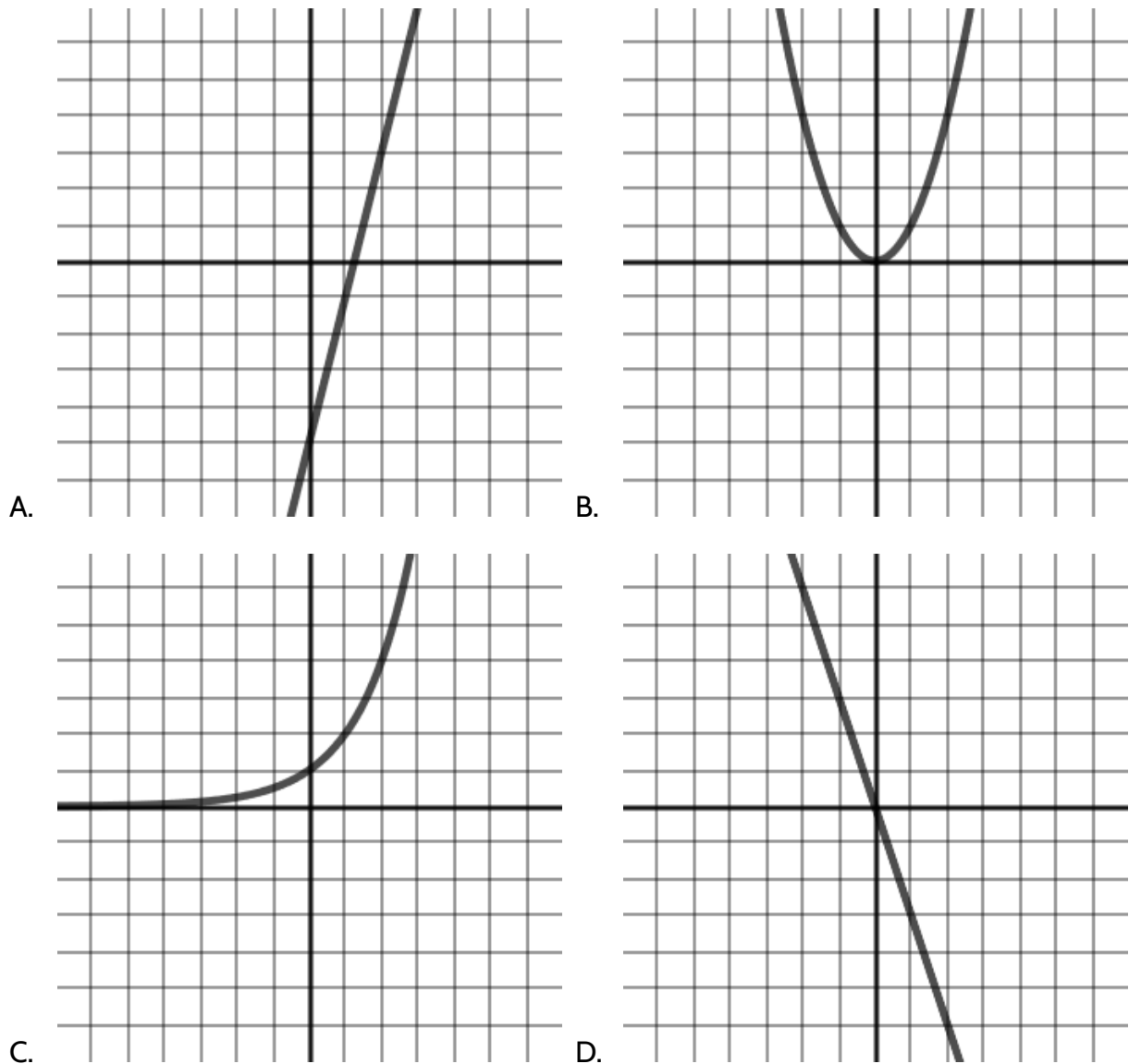
There are many examples of linear growth in the world: The price of produce per pound, the size of a paycheck with an hourly wage, the cost of a taxi ride, the amount of tax paid on a purchase, conversion of temperature in Fahrenheit to Celsius, etc. All of these situations involve functions where one quantity grows steadily in relationship to another quantity.

If you plotted data from any of the situations above, you would get a line graph. This is because the rate of change is constant. In order to predict the next consecutive amount, you can always add the rate of change.

**The rate of change is the change in the outputs when the inputs are consecutive.**

However, linear growth is not the only way that growth happens in the world. There are many situations where the amount of growth is not constant. In these situations, the growth is *nonlinear*, meaning it would not form a line on a graph if you plotted the data points. With nonlinear growth, there isn't a constant rate of change, so there isn't one number we can add to get the next number in a pattern. However, there are often other ways of using patterns to understand nonlinear growth.

2) Which of these graphs show nonlinear functions?

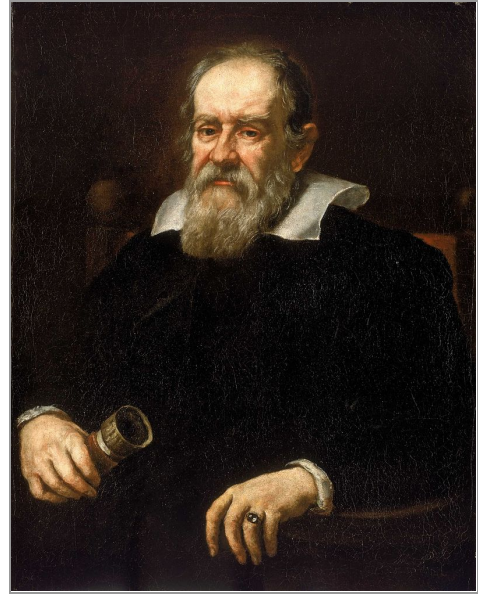


We will look at two kinds of nonlinear growth in this packet, *quadratic* functions and *exponential* functions. For each type of functions, we will look at number patterns, visual patterns, function tables, equations, and graphs. We will also look at examples of how quadratic and exponential functions are used to understand different kinds of growth in the world.

Note: We recommend using TI-30XS calculator throughout this packet.

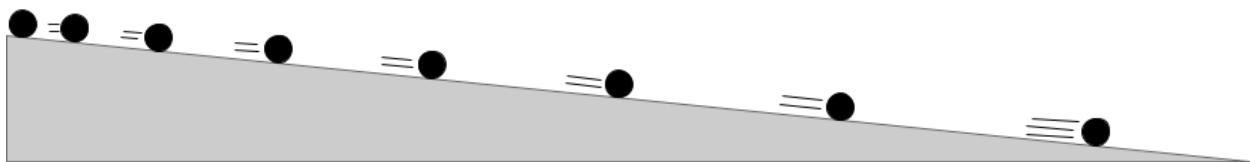
## Investigating Gravity

Galileo Galilei (1564-1642) was a scientist and mathematician who lived in the city of Pisa in what is now Italy. He was interested in the movement of planets, moons, and stars, and built telescopes to better observe them. Galileo was able to see that there are mountains on the moon, for example.



At the time, the Catholic Church taught that Earth was the center of the universe and did not move. They believed that all planets and stars revolved around Earth. Based on the work of Nicolaus Copernicus and his own observations, Galileo believed that the planets in the solar system, including Earth, revolved around the sun. Galileo was eventually arrested and found guilty of having beliefs in contradiction to the Church's teaching. He was sentenced to house arrest for the rest of his life and his books were banned. He experienced another tragedy as an old man when he became blind due to looking at the sun through a telescope.

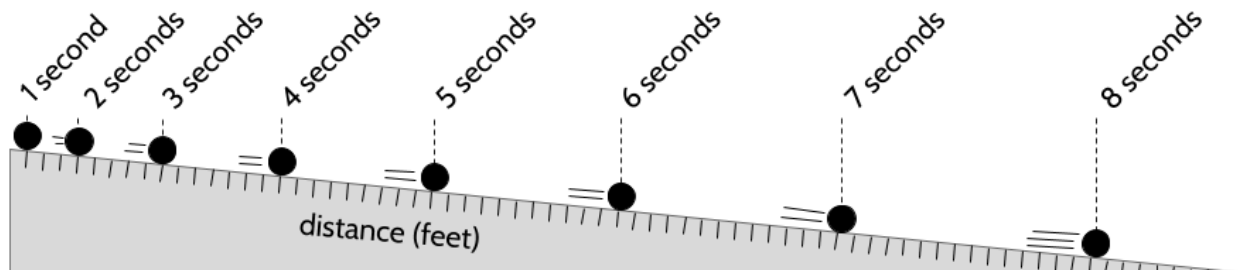
Even while confined to his home, Galileo continued to make many contributions to the field of science. One of Galileo's major discoveries was how Earth's gravity affects falling objects. It was really difficult to measure the speed of falling objects since they move so quickly. In order to understand gravity, Galileo figured out a way to reduce the effects of gravity and slow down falling objects so that he could see what was happening. In his experiment, he rolled balls down inclined planes to see how quickly the balls sped up. He placed each ball at the top of a ramp and then measured how far it went as time went by.

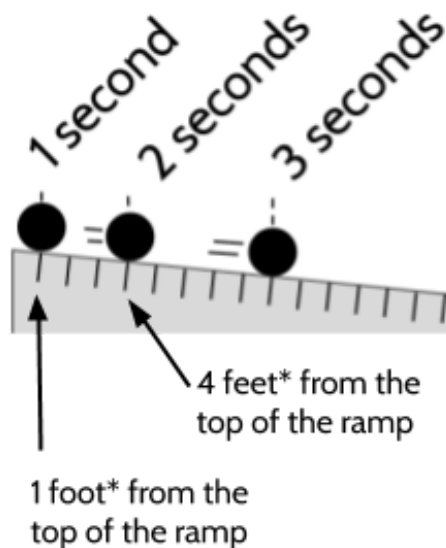
Galileo noticed a pattern in the distance that the ball traveled as it rolled down the ramp. The diagram below shows a modern version of the inclined plane experiment, using current technology to measure time and distance. Imagine that a photograph is taken every second as the ball rolls down the ramp. The horizontal marks below the ramp show the distance the ball travels.



After 1 second, the ball travels 1 foot.

- 7) If the ramp was longer and the ball continued rolling, how far would it travel after 10 seconds?
- 8) Galileo looked at the distance traveled and noticed some patterns. What patterns do you notice in the distances traveled?

To find patterns in a function table, one thing we can do is look at the rate of change in the outputs. For example, from 0 seconds to 1 second, the change in distance is 1 foot. From 1 second to 2 seconds, the change in distance is 3 feet.

- 9) Write in the change in distance for the rest of the table on the right.

The distance traveled in a certain amount of time is the speed. The change in distance in each second is the speed of the ball as it rolls.

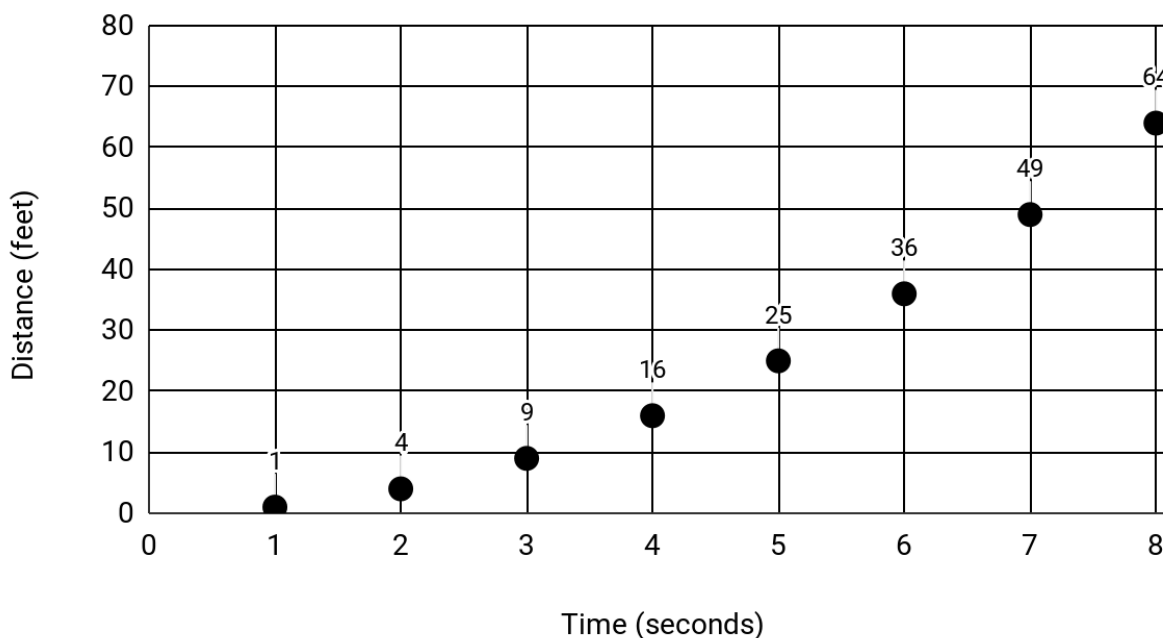
If you look at the change in the outputs in a linear function, the rate of change will be constant (the same number). In the inclined plane experiment, the change in distance (speed) doesn't stay the same. The speed changes as the ball rolls faster and faster down the ramp. The change in speed is called *acceleration*.

- 11) What patterns do you see in how the change in distance (speed) is increasing?

- 12) Is the rate of change constant?

When we look at the rate of change for this table, we can see that the difference between each output is changing as time passes. The change is 1, then 3, then 5, then 7, etc. The rate of change is changing! This tells us that the growth is nonlinear.

Rolling a Ball Down a Ramp



- 13) Connect the circles on the graph with a pencil. Can you make a straight line that goes through all of the circles?

The acceleration (change in speed) of a ball rolling down a ramp is an example of a quadratic function, which is a kind of a nonlinear function. The growing distance is a function of the time spent rolling down the ramp. We will spend more time exploring gravity and other quadratic situations later in the packet.

## Choose Your Salary

I would like to offer you a job for thirty days. You will only need to work one hour each day. The interesting part is that I am going to let you decide how you want to be paid. If you like, I will pay you \$1,000 per day. Your other option is to be paid 1 penny on the first day, 2 pennies on the second day, 4 pennies on the third day, and so on, each day earning twice as many pennies as the day before.

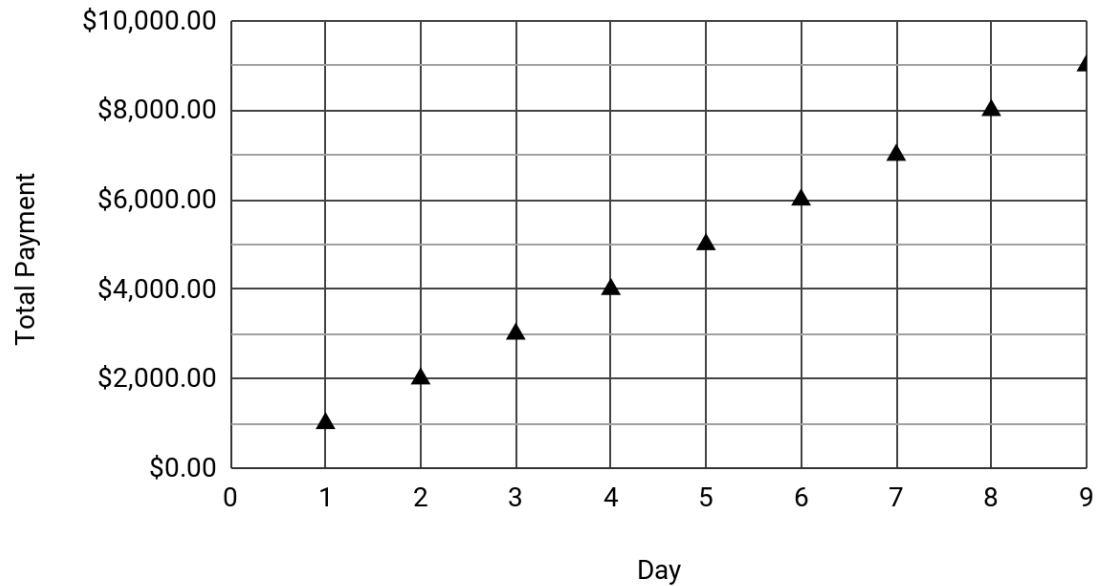

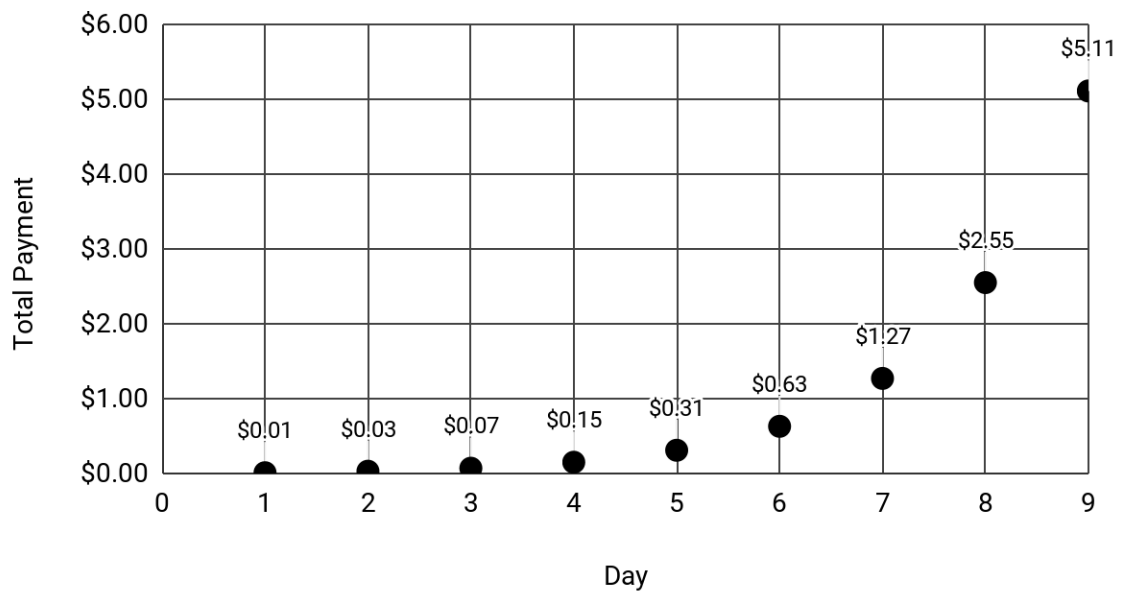

The thousand dollars per day payment option is an example of a linear growth function. The total payments of a thousand dollars a day form a straight line on a graph. The doubling pennies payment option is an example of an exponential growth function, which is a type of nonlinear function. The graph of the total payments of doubling pennies is a curve, not a straight line.

We will return to the doubling pennies and other exponential functions later in the packet.



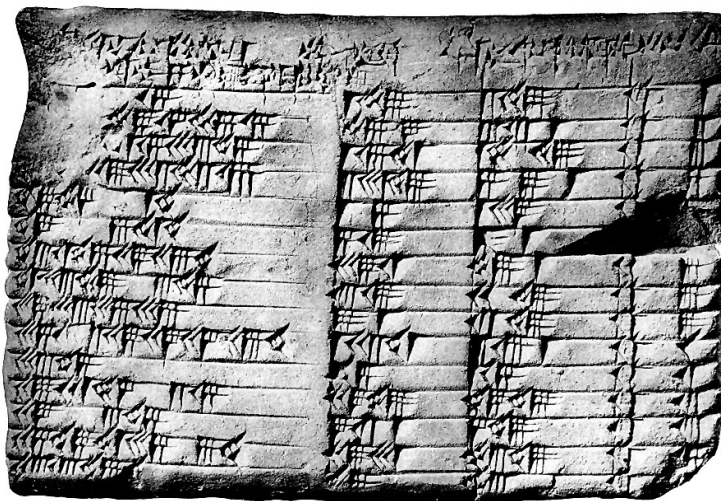
19) The graph of the thousand-dollars-per-day payment method is a straight line. To predict the total payment, we can multiply the number of the day by \$1,000.

The graph of the doubling-pennies method is not a straight line. The amount paid each day doubles each day. The pay is tiny for the first few days, but then keeps getting larger as time goes on. We can predict that the pay would keep doubling as time goes on.

Use the information you have so far to make a decision about which payment method you would choose. Feel free to keep calculating the total pay for each method for more days. We will return to this problem later in the packet.

## Introduction to Quadratic Functions

More than 3000 years ago, the Babylonian people, who lived in present-day Iraq, developed techniques for solving many mathematical problems related to the management of business and agriculture (farming and producing food). They kept track of their calculations on clay tablets. Many of these tablets have been found. After analyzing the tablets, modern mathematicians found that the Babylonians had discovered many tools of algebra. For example, they calculated area and volume, squares and square roots, and understood quadratics and exponential growth (though the idea of a function was something that came much later).



The word *quadratic* comes from the root word *quad*, which means “four.” Geometric figures with four sides are called *quadrilaterals*. The root word *quad* is used in the word *quadratic* because these functions are based on squares, which have four sides.

- 1) On the right is an example of a quadratic function in a table. Find the missing outputs.

The rule for this function table ( $Out = In \times In$ ) could also be written as  $y = x \cdot x$  since  $x$  can represent the input to a function and  $y$  can represent the output. The function could also be written as  $y = x^2$  or  $f(x) = x^2$ . Each of these equations are equivalent to each other.

## Number Patterns

In the high school equivalency test, you will need to figure out whether you are looking at a linear, quadratic, or exponential function. You may be given a number pattern, an equation, an input/output table, a graph, or a visual pattern. In this packet we will practice analyzing all of these so that you will understand what kind of function you are looking at.

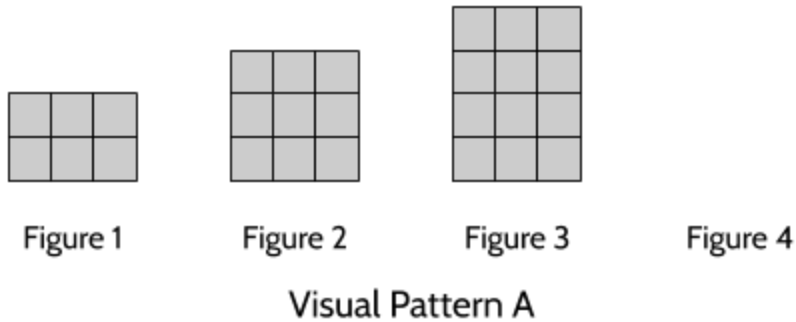

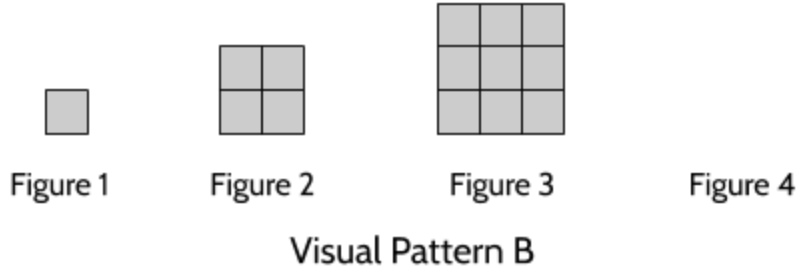




Figure 1      Figure 2      Figure 3




Figure 1      Figure 2      Figure 3

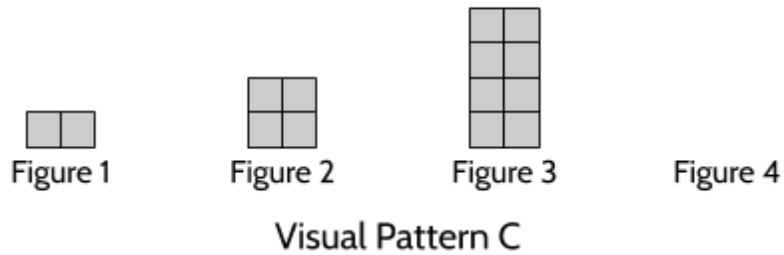

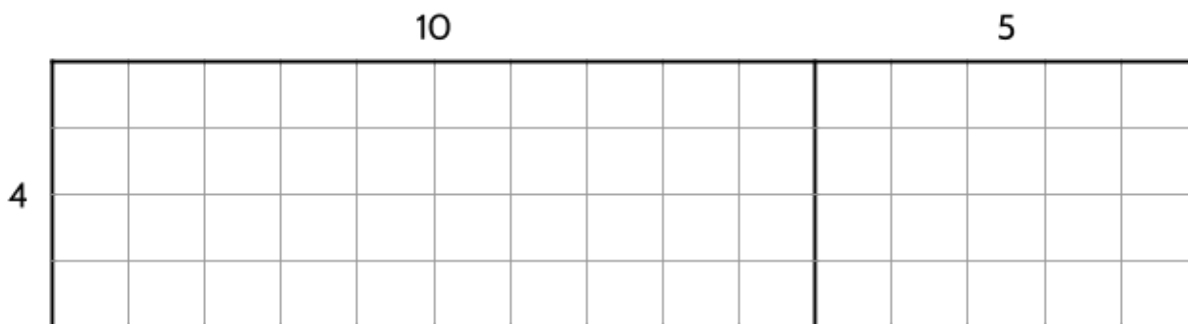
One of these functions is linear, one is quadratic, and one is exponential. We will examine each of these functions later in the packet.



## Area Models and Quadratic Functions

An area model can be used to understand multiplication. We will use it here to see how multiplication is an important part of how quadratic functions work.

In **Tools of Algebra: Expressions, Equations, and Inequalities**, we used area models to write equations for the area of rectangles. Here is an example of an area model of multiplication:



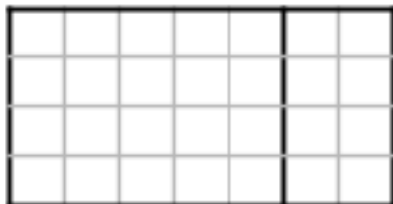
$$(4 \cdot 10) + (4 \cdot 5) = ?$$

$$40 + 20 = 60$$

The area of a rectangle (or the number of small squares that fill the space) can be found by multiplying the length by the width. Using the distributive property<sup>2</sup>, we can find the area of the rectangle on the left by multiplying 4 by 10. Then we can find the area of the rectangle on the right by multiplying 4 by 5. Finally, we can find the total area by adding those two products ( $40 + 20$ ) to get 60. This is one way of multiplying  $4 \times 15$  to get 60.

We could also use a table to find a solution to the problem. We will use the table to record our attempts, but we have to remember that the length has to be 4 inches longer than the width. When we find a rectangle which has a length 4 inches longer than the width and also has an area of 60 square inches, we will know that we have the right answer.

Let's try different measurements to see what works. Maybe the width is 3 inches and the length is 7 inches? That would give us an area of 21 square inches. Too small.

How about a width of 10 inches and a length of 14 inches? The area would be 140 square inches. Too big.

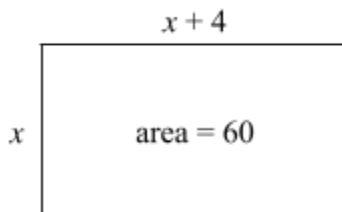

We can also use variables to understand this problem. Here is a sketch of the rectangle using the variable  $x$  to represent the width:



Width	Length	Calculation	Area
$x$	$x + 4$	$x(x + 4)$	60

The length is always 4 inches more than the width, so the expression  $x + 4$  represents the length. The width ( $x$ ) times the length ( $x + 4$ ) is equal to the area (60). The area of this rectangle can be shown by the equation below:

$$x(x + 4) = 60$$

Using the distributive property, we can multiply  $x$  by  $x + 4$  to get  $x^2 + 4x$ , which means the equation could also be written as:

$$x^2 + 4x = 60$$

Here is the original problem, which we have represented with the equation above:

A rectangle has an area of 60 square inches and a length that is 4 inches longer than its width. What are the dimensions of the rectangle?

One way to solve the problem is to write the equation  $x(x + 4) = 60$  and then find a value for  $x$  that makes the equation true. The value of  $x$  that makes the equation true is 6, since  $6(6 + 4) = 60$ , so the answer to the question is: A width of 6 inches and a length of 10 inches.

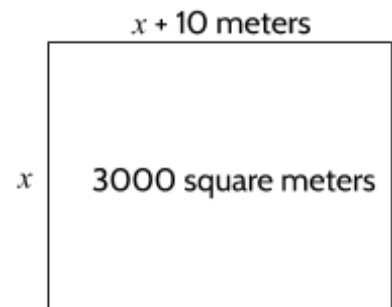

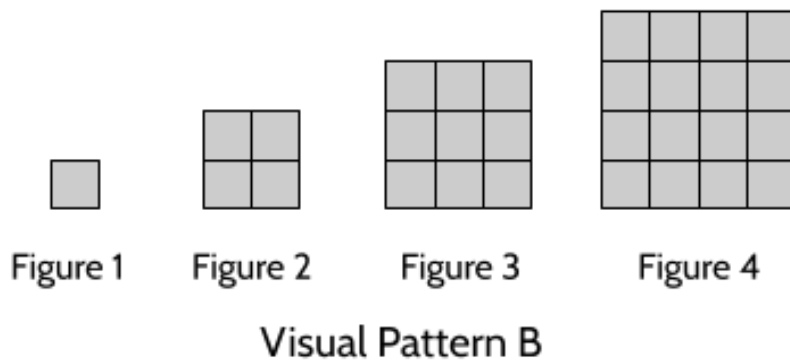


### Where's the Square?

The word quadratic comes from the root word quad, which means “four.” Geometric figures with four sides are called quadrilaterals. The root word *quad* is used in the word *quadratic* because these functions are based on squares, which have four sides.

Take a look at this visual pattern from the previous section.

The number of squares in each figure (1, 4, 9, 16, etc.) can be predicted with the function rule  $y = x^2$  where  $x$  is the figure number and  $y$  is the number of squares in the figure.

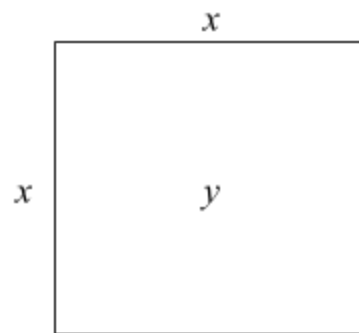

$x(x + 4)$  and  $x^2 + 4x$  are examples of quadratic expressions. They are named *quadratic* because the  $x \cdot x$  and  $x^2$  terms are related to squares. But where are the squares in these expressions?

The rectangles on the right show  $x(x + 4)$  and  $x^2 + 4x$  (the same figures since the expressions are equivalent). You can see squares if you look at rectangles drawn for different values of  $x$ . The  $x^2$  section of each rectangle is shaded.

Here are some other examples of quadratic expressions:

There are many ways to break up the  $14 \times 16$  rectangle into smaller rectangles, in order to calculate the total area. We split the height into  $10 + 4$  and the width into  $10 + 6$ .



The areas of the smaller rectangles can be calculated by multiplying the length and width of the smaller rectangles.

### **$14 \times 16$ using rectangles**

$$\begin{aligned} & (10 + 4)(10 + 6) = \\ & (10 \cdot 10) + (10 \cdot 6) + (4 \cdot 10) + (4 \cdot 6) = \\ & (100 + 60 + 40 + 24) = 224 \end{aligned}$$

Tools of Algebra: Nonlinear Functions (Part 1)

Breaking up the area of a rectangle into pieces is similar to a method of multiplying called *partial product multiplication*, which is how many young people are currently learning how to do multiplication. Partial product multiplication lets you calculate the *products* (result of multiplication) one piece at a time. That is why they are called *partial*, since you calculate them one part at a time. One benefit to partial product multiplication is that you don't have to remember to "carry" numbers when you multiply. It can also be easier to organize multiplication with large numbers, since you don't have to remember as many numbers.

Here's an example with  $18 \times 15$ .

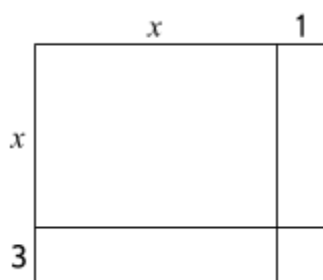

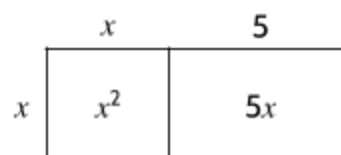
Different algebraic expressions can be equivalent to each other. The expressions  $x(x + 5)$  and  $x^2 + 5x$  are equivalent. You can see this with an area model that shows multiplication of  $x$  by  $x + 5$  in two ways:

In the first figure,  $x \cdot (x + 5)$  is equal to  $x(x + 5)$ .



In the second figure,  $x \cdot (x + 5)$  is equal to  $x^2 + 5x$ .

The area of the two rectangles is equal, so  $x(x + 5) = x^2 + 5x$ .

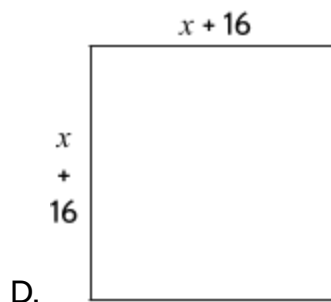
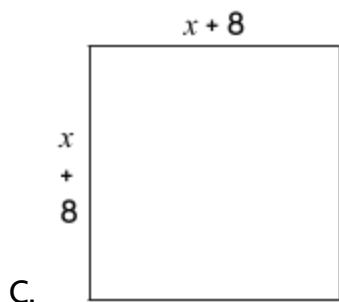
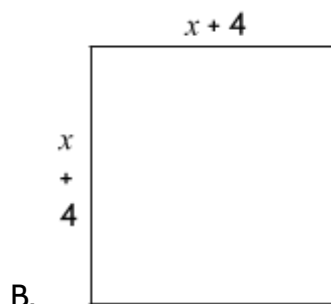
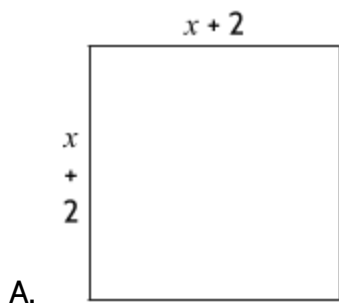


You can also use the distributive property to show that  $x(x + 5)$  and  $x^2 + 5x$  are equivalent.

$$\begin{aligned} x \cdot (x + 5) &= (x \cdot x) + (x \cdot 5) \\ &= x^2 + 5x \end{aligned}$$

The expression  $x(x + 5)$  is in its *factored* form. *Factors* are the values that are multiplied together to get another value. A *product* is the result of multiplication. In this case,  $x$  can be multiplied by  $x + 5$  to get  $x^2 + 5x$ , so  $x$  and  $x + 5$  are considered factors of  $x^2 + 5x$ , which is a product of the two factors. The expression  $x^2 + 5x$  is considered the *standard form* of these two equivalent expressions.

## Three Views of a Quadratic Function

Functions show us how quantities change in relation to each other. Quadratic functions have growth patterns related to the size of different squares. All quadratics include an  $x^2$  ( $x$  “squared”) term.

We can represent functions in different ways to help us see the change in different ways. In **Tools of Algebra: Linear Functions**, we looked at three views of a function: a table, an equation, and a graph. Like linear functions, quadratic functions can be represented with each of these views. We will see differences when we compare quadratic tables, equations, and graphs with representations of linear functions.

### Tables

Let’s start by looking at some quadratic functions in a table format. Use number patterns to find the missing outputs.

The first table on the previous page is for a linear function. We can tell that is a linear function because the *rate of change* (the difference in the outputs when the inputs are *consecutive*<sup>5</sup>) is constant. Since the rate of change is +2 between the outputs of 2 and 4, and between 4 and 6, we can predict that the output will be 8 for an input of 4. Each output is 2 more than the previous output.

The second table on the previous page is for a quadratic function. We can tell that it is not a linear function because the *rate of change* is not constant. Between the output of 3 and the output of 6, there is a rate of change of +3. Between the output of 6 and the output of 11, there is a rate of change of +5. Since the change between each output is not the same, we know the function is not growing at a constant rate of change.

If you look at the difference in the outputs of the function above, you will see that the rate of change stays the same between each output. Since the rate of change is constant, the function below is linear.

On the other hand, the other four functions on the previous page have a rate of change that is changing. The changing difference between the outputs lets us know that these are nonlinear functions. For example, the function below is nonlinear.

## Rules and Equations

A function is a relationship between an input and output. The inputs are the numbers that are put into the function. The function does something to the input and produces the output number. One way to look at a function is by understanding its rule or equation. The function rule determines what the function does to the input.

Here is an example of a function rule written as a number sentence:

Multiply the input by 3 more than the input.

Any number that is put into the function is multiplied by a number that is 3 more than the original number:

$$0 \cdot 3 = 0$$

$$1 \cdot 4 = 4$$

$$2 \cdot 5 = 10$$

$$3 \cdot 6 = 1 \cdot 8$$

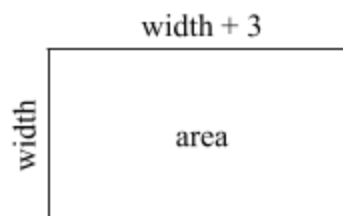
$$4 \cdot 7 = 2 \cdot 8$$

Etc.

This same rule can be shown with the area of a rectangle. To calculate the area, we multiply the width by the length:

$$\text{width} \cdot (\text{width} + 3) = \text{area}$$

The area of the rectangle is a function of the width of the rectangle. As the width changes, so does the area. If the width is 1, then the area is 4. If the width is 2, then the area is 10. Each input of the width produces an output of the area.

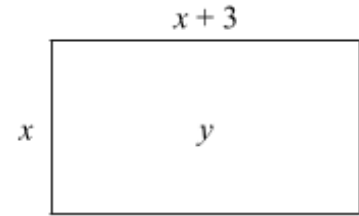

We can also use variables to show this rule in an equation. The rectangle on the right shows the relationship between *width* and *area*. Instead of using *width*, we now use the variable  $x$ , and instead of *area*, we use  $y$ .

$$x(x + 3) = y$$



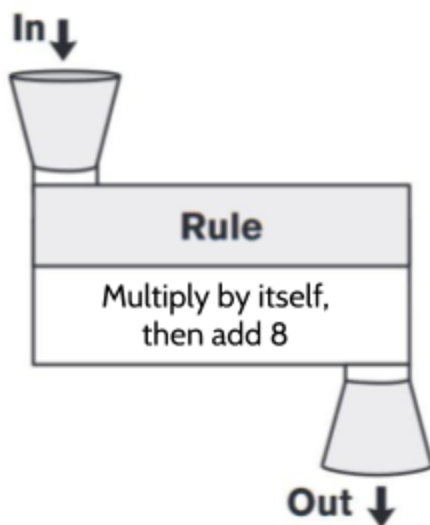
In this equation, the area of the rectangle ( $y$ ) is a function of the width of the rectangle ( $x$ ). As the value of  $x$  changes, so does the value of  $y$ . Each input of  $x$  produces an output of  $y$ .

In the rest of this section, we will practice using function rules and equations with variables to complete function tables.

In the following function machine, the function rule is “*Multiply by itself, then add 8.*” Following the rule, when the number 0 placed in the machine, the rule is applied to the input number, which is multiplied by itself, then added to 8. The number 8 comes out of the function machine.

In the following pages, we will use function machines and keep track of our calculations with function tables. We add a *Calculation* column in each table to show how we find the output number.

As we know, the function rule can also be written as an equation. The word *equation* comes from the word *equal*. In mathematics, an equation shows that the expression on one side of the equals sign is equal in value to the expression on the other side. Here is an example of the previous function rule written as an equation:

$$Out = In \cdot In + 8$$

This can be read as, “The output is equal to the input multiplied by itself and added to 8.” In function equations, the output is usually on the left side of the equation and the function rule, including the input, is on the right side of the equation.

The function equation can also be written with the variables  $x$  and  $y$ :

$$y = x \cdot x + 8$$

In the equation,  $x$  is the input number and  $y$  is the output number.


You will also sometimes see the output written as  $f(x)$ . This can be read as “the function of  $x$ ” or “ $f$  of  $x$ ” and means the same thing as  $y$ . Both  $y$  and  $f(x)$  refer to the output of the function.

There are many ways of writing function rules and equations. Each of the following equations mean the same thing:

Input	Output	Equations
$In$	$Out$	$Out = In \cdot In + 8$

You may have noticed that the outputs for  $y = (x + 2)(x + 3)$  and  $y = x^2 + 5x + 6$  are the same. This is because the two functions are equivalent. We can see this by multiplying  $(x + 2)$  and  $(x + 3)$ :

$$\begin{aligned} (x + 2) \cdot (x + 3) &= (x \cdot x) + (x \cdot 3) + (2 \cdot x) + (2 \cdot 3) \\ &= x^2 + 5x + 6 \end{aligned}$$

We can also use an area model to show how  $(x + 2)$  multiplied by  $(x + 3)$  is equal to  $x^2 + 5x + 6$ :

### Connecting Equations and the Function Table

By analyzing equations, we can predict some features of the function table. For example, let's review how we have been able to use the equation of a linear function to predict the rate of change and starting amount in the function table:

In a linear function, the coefficient of  $x$  (the number multiplied by  $x$ ) tells us the rate of change of the function. In this table, we can see that the rate of change is 3. We see it multiplied by  $x$  in the equation rule and also in the difference between outputs in the function table.

Rule: $y = 3x + 5$	
$x$	$y$
0	5
1	8
2	11

The starting amount (value of  $y$  when  $x$  is 0) can be seen in the equation and in the table. If  $x$  is 0, then  $y$  is 5. The + 5 at the end of the equation is connected to the 5 next to the 0 in the function table.

When a linear function is shown on a graph, the rate of change is called *slope* and the starting amount is called the *y-intercept*.

Look at the function equation  $y = 2x + 10$ .

As we have seen, quadratic functions don't have a constant rate of change, so we won't be able to find the rate of change in the equation. However, there are other features of the function table that we can predict by looking at the function equation.

Let's look at  $y = x^2 + 5x + 6$  for  $x = 0$ .

$$y = 0^2 + 5(0) + 6$$

$$y = 6$$

The value of  $y$  is 6 when  $x$  is 0. That is the definition of starting amount. If you look at the function table for  $y = x^2 + 5x + 6$  on the right, you can see the starting amount in the table there as well. When  $x$  is 0,  $y$  is 6.

We can use the function equation in standard form to predict the value of  $y$  when  $x$  is 0 (the starting amount).

When  $y$  is 0,  $x$  has two possible values. It is either -3 or -2. Let's look at the equation calculations to see why there are two possible  $x$  values for  $y = 0$ .

When  $x$  is -3:

$$y = (x + 2)(x + 3)$$

$$y = ((-3) + 2) \cdot ((-3) + 3)$$

$$y = (-1) \cdot (0)$$

$$y = 0$$

When  $x$  is -2:

$$y = (x + 2)(x + 3)$$

$$y = ((-2) + 2) \cdot ((-2) + 3)$$

$$y = (0) \cdot (1)$$

$$y = 0$$

The  $x$ -values -3 and -2 are called the *roots* of the function  $y = x^2 + 5x + 6$ . A *root* is a value you can put into a function as an input for  $x$  so that 0 comes out as an output for  $y$ .

The *roots* are values you can use for  $x$  so the value of  $y$  is 0. The word *zero* is sometimes used to mean the same thing as *root*. The roots/zeros are the solutions to a function equation. If you are asked to solve a quadratic equation, this usually means that you should find the values of  $x$  that will produce a  $y$ -value of 0. One thing to notice is that quadratic equations will often have 2 solutions!

You may have noticed that the equation  $y = (x + 2)(x + 3)$  includes the numbers 2 and 3, the positive versions of -2 and -3, which are the solutions (or roots) to the function. Do you think this happens with other function equations?

The solutions (or zeros) are the  $x$ -values when the  $y$ -values are 0. In the last two functions, we found those numbers in the factored form of the function equation. The starting amount is the  $y$ -value when the  $x$ -value is 0. We found the starting amount in the standard form of the function equation.

Factored Form	Solutions	Standard Form	Starting Amount
$y = (x + 2)(x + 3)$	-2 and -3	$y = x^2 + 5x + 6$	6
$y = (x + 5)(x - 3)$	-5 and 3	$y = x^2 + 2x - 15$	-15

Notice that the factored form of the equation shows the solutions, but the numbers are opposite. For example, the factor  $(x + 2)$  tells us that one of the solutions is -2. Similarly, the factor  $(x - 3)$  reveals that one of the solutions is 3. The number in the factored form is the opposite of the solution. If the number in the factored form is positive, the solution is negative. If the number in the factored form is negative, the solution is positive.

Let's see why this is true by looking at another function in factored form:  $y = (x - 2)(x + 7)$ . We could find the zeros with a function table. Or we could use what we have noticed about opposite numbers in the function equation. Instead of those two methods, let's try another way.

Let's start by looking at the factored form of the equation:  $y = (x - 2)(x + 7)$ . On the right side of the equation, we have  $(x - 2)$  multiplied by  $(x + 7)$ . The values of each of these expressions will change depending on the value of  $x$ , but we know that we want the product of the two expressions to be 0. This is because we need the right side of the equation to equal the left side of the equation when  $y = 0$ . So, when  $y$  is 0,  $(x - 2)$  multiplied by  $(x + 7)$  has to be 0 as well. In other words, the product of  $(x - 2)$  and  $(x + 7)$  must be 0.

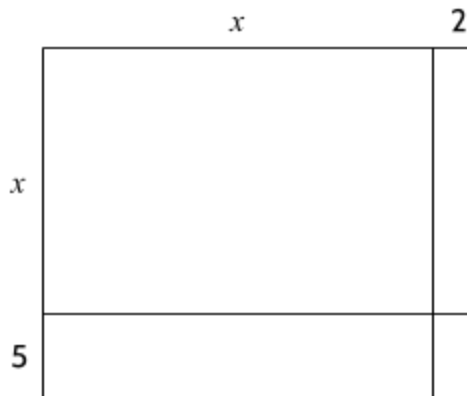

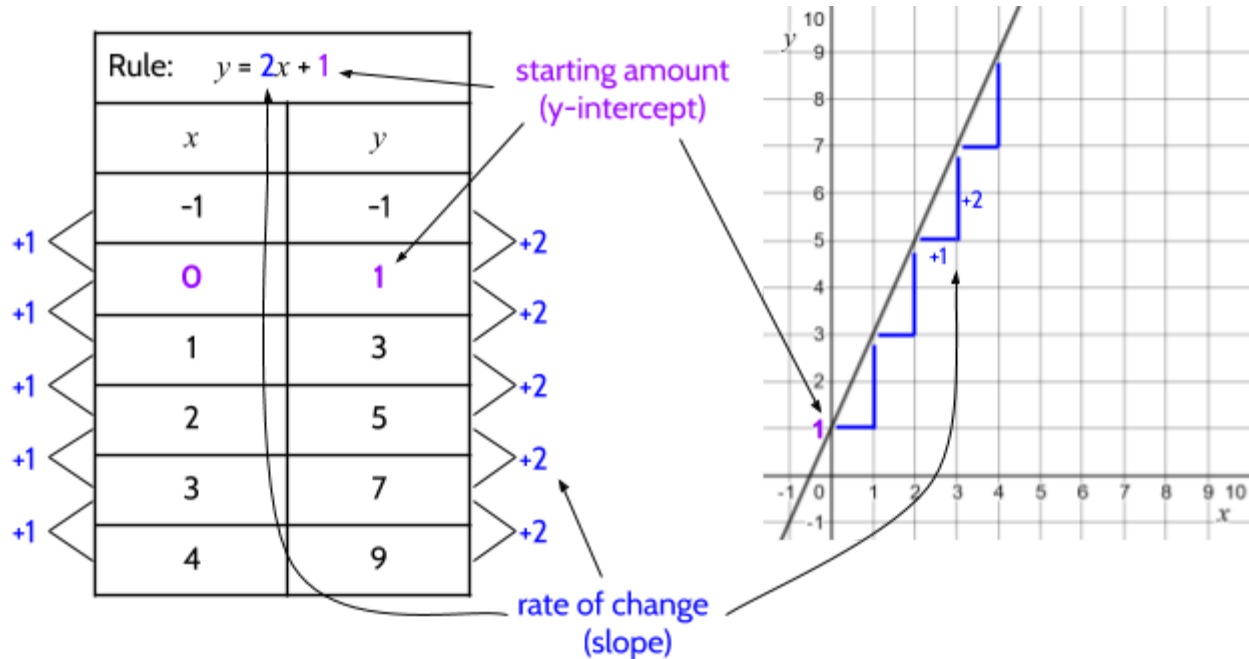

As we looked at earlier, we can analyze the equation of a linear function to make predictions about what the function table and the graph of the line will look like. For example, we can look at the linear function  $y = 2x + 1$  and see two things at a glance:

- The starting amount (y-intercept) is 1.
- The rate of change (slope) is 2.

We can also look at the table and the graph of the linear function to see these same features:



A common form of a linear equation is  $y = mx + b$ , where  $m$  is the rate of change or slope and  $b$  is the starting amount or y-intercept. In the linear function above,  $m = 2$  and  $b = 1$ . We can look at the value of  $m$  in order to know the rate of change in a linear function, or the slope of the line, and the value of  $b$  tells us the starting amount, or where the line crosses the  $y$  axis.

Quadratic functions in standard form are written as  $y = ax^2 + bx + c$  where  $b$  and  $c$  can be any number and  $a$  can be another number except 0.

## Graphs

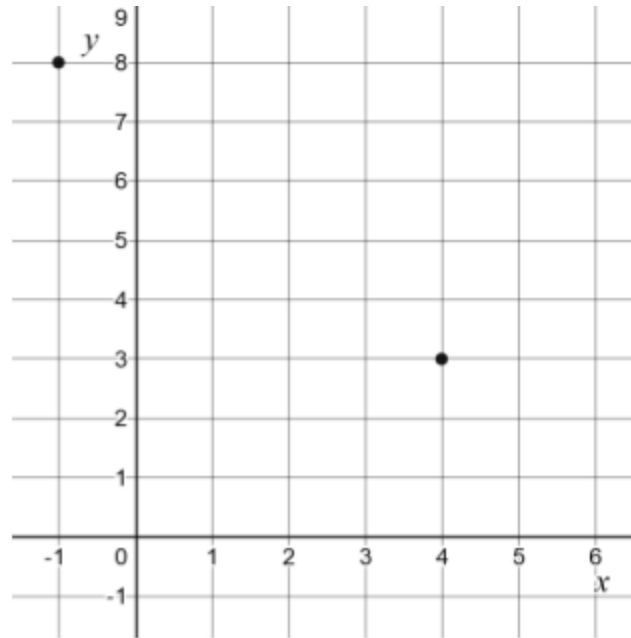
Along with equations and tables, graphs are an important way to understand functions, including quadratics. In this section, we will explore the graphs of quadratic functions.

The graph of a linear function is a line, but what does the graph of a quadratic function look like? Let's start by plotting the data from a function to create a graph.

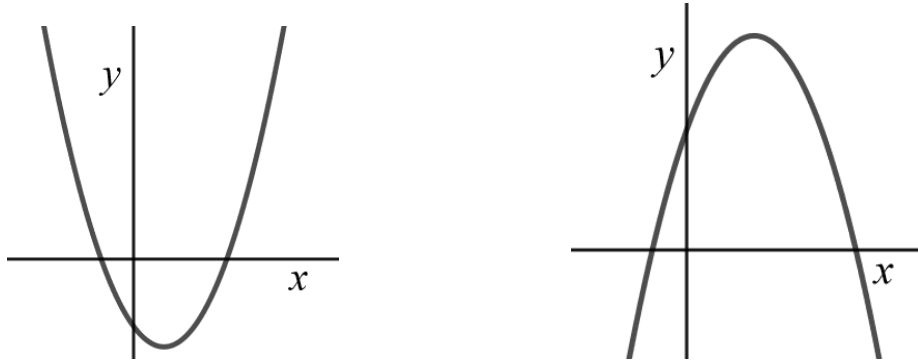

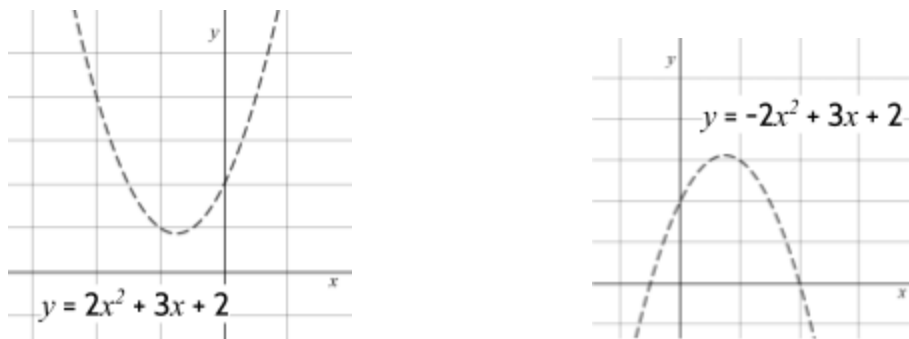
The curved shapes in the graphs are called parabolas. Every quadratic function looks like a parabola when it is graphed on the coordinate grid.



Sometimes parabolas open up like the one on the left, and sometimes they open down like the one on the right.

Imagine someone throwing a ball in the air. Wouldn't it look like the parabola on the right? It turns out that that is exactly the path a projectile takes if it is shot through the air. Balls, arrows, and rockets all follow the path of a parabola. This is because of the way gravity pulls things back to Earth. The scientist Galileo figured this out 400 years ago. This is why we can use quadratic equations to calculate how objects move through the air. We'll come back to this later in the packet.

Take a look at the equations  $y = 2x^2 + 3x + 2$  and  $y = -2x^2 + 3x + 2$  and their graphs.

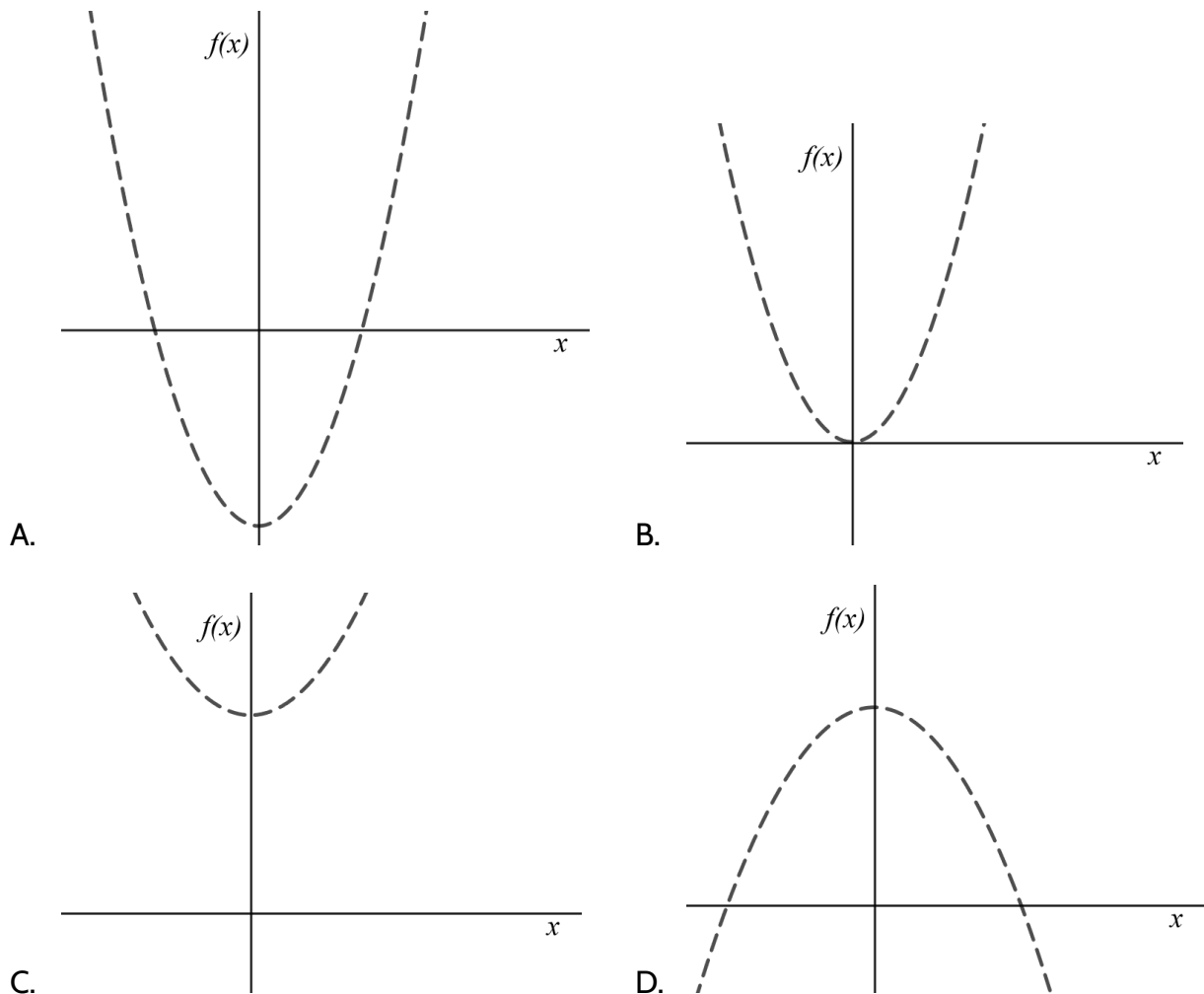

You may have noticed that the function  $y = -2x^2 + 3x + 2$  has a negative 2 as the coefficient for  $x^2$  and the graph is a parabola opening down. Remember that quadratics can be written in the form  $y = ax^2 + bx + c$ . If  $a$  is a negative number, the graph will be a parabola opening down with the rounded part on the top.

On the other hand, the function  $y = 2x^2 + 3x + 2$  has a positive value for  $a$ , which means that the graph is a parabola opening up, with the rounded part on the bottom.

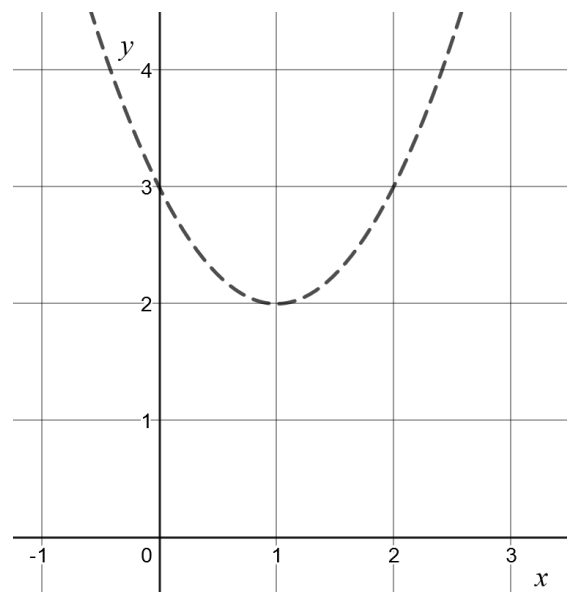
The function table and graph for  $y = (x - 3)(x + 1)$  is below. Notice that the parabola crosses the  $x$  axis at  $-1$  and  $3$ . This brings us to another name:  $x$ -intercepts. Amazingly, this is another name that means the same thing as *roots*, *solutions*, and *zeros*. The  $x$ -intercepts are the values of  $x$  when the graph intersects with the  $x$ -axis. In this function, the  $x$ -intercepts are  $-1$  and  $3$ .

Equation: $y = (x - 3)(x + 1)$

There is another feature of quadratic functions that you may have noticed. In some graphs, like the one above, there is a minimum value for  $y$ . In the function  $y = (x - 3)(x + 1)$ , the minimum is  $-4$ . You can see this in the function table and in the graph. The  $y$ -value of  $-4$  happens when the input is  $1$ . This is the smallest output possible with this function. If the input is larger than  $1$ , then the outputs are larger than  $-4$ . If the inputs are less than  $1$ , the outputs are also larger than  $-4$ .

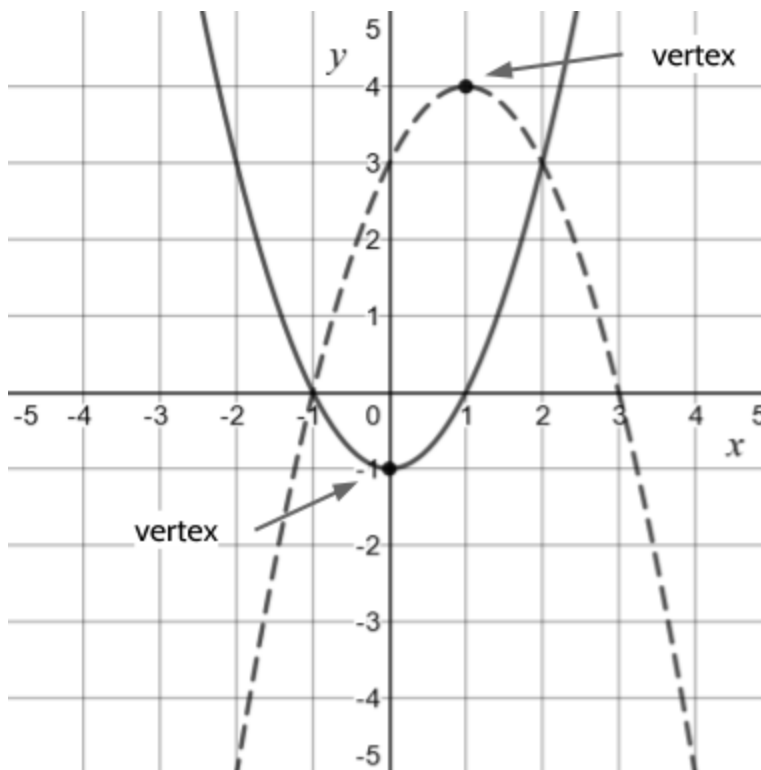

With some quadratic functions, the minimum  $y$ -value marks the bottom of the parabola. Other functions have a maximum value for the outputs that marks the top of the parabola. The lowest or highest point on a parabola is called the *vertex*.

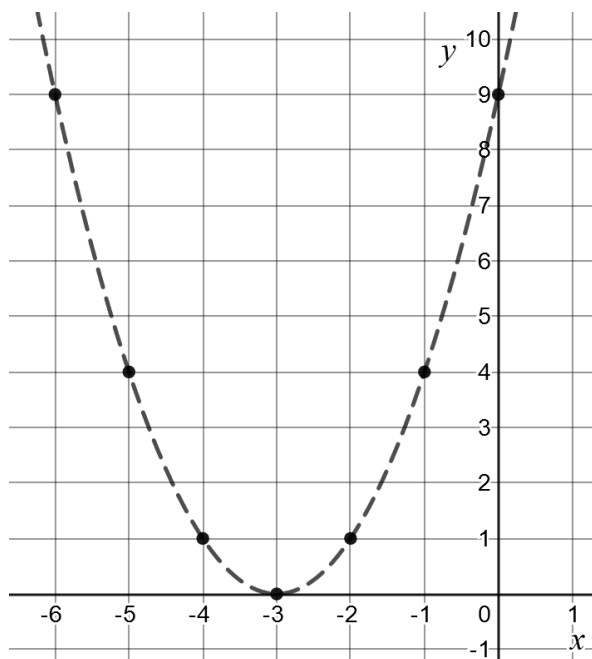

## Squaring and Multiplying

In this activity, you will use a calculator to look for patterns when squaring and multiplying numbers. Of course, you don't have to use a calculator, but it will make it much faster if you do. We recommend the TI-30XS since it used on most high school equivalency exams.




### Raising number to the second power (AKA “squaring”)


Squaring a number is the same as raising it to the second power or multiplying the number by itself. Here are a few examples:

$$\begin{array}{lll} 5^2 = 25 & 10^2 = 100 & 15^2 = 225 \\ 5 \times 5 = 25 & 10 \times 10 = 100 & 15 \times 15 = 225 \end{array}$$

You can square numbers quickly in a calculator by using one of these two buttons:



Using the TI-30XS to find  $12^2$ , you can enter 12, then , and hit Enter. 144 should be displayed.

Another way to find 12 to the 2nd power is to enter 12, then , then 2, and hit Enter. The ^ key can be used to calculate any power (2nd power, 3rd power, 4th power, etc.)

In this exercise, you will practice squaring numbers and then make connections to algebra.

Enter a two-digit number into your calculator and then raise it the 2nd power.

For example:  $35^2 = 35 \cdot 35 = 1225$

Then, multiply the numbers that are 1 more and 1 less than the number you chose:

$$36 \cdot 34 = 1224$$

Finally, compare the square of your original number with the product of the numbers that are 1 more and 1 less.

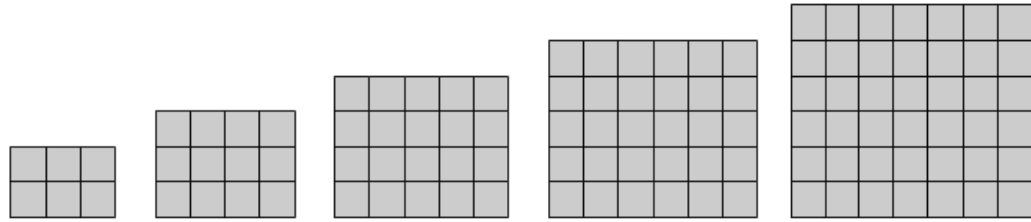

In the second part of this packet, we used functions to understand quadratic growth in the world. We will come back to the example of gravity and learn how acceleration follows quadratic patterns. We will also look at other examples of quadratic growth in science, business, and everyday life.

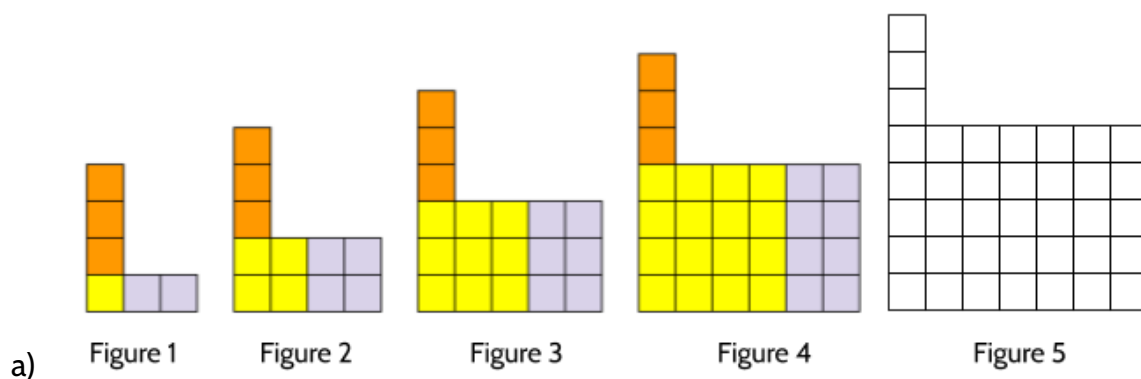

## Vocabulary Review

### Glossary

You can use this section to look up words used in this math packet.

**consecutive** (adjective): Numbers which follow each other one after the other, without gaps. The numbers 3, 4, 5, 6 are in consecutive order.

**constant** (noun): A value in an expression or equation that doesn't change. For example, in the function  $y = 4x + 6$  the numbers 4 and 6 are both constants.

**constant** (adjective): Something that stays the same. A *constant* rate of growth means that the rate stays the same over time.

**distributive property of multiplication** (noun): a mathematical property that shows multiplying a number by a group of numbers added together is the same as doing each multiplication separately. For example,  $3 \cdot (2 + 4)$  is equal to  $3 \cdot 2 + 3 \cdot 4$ .

**equal sign**: a symbol used to show symmetric balance between two values or quantities, one on each side of the equal sign. Can be read as "is equivalent to" or "is the same as".

**equation** (noun): A number sentence that shows two expressions are equal by using the equal sign.  $2^3 = 8$  is an *equation*.  $5x + 3$  is an expression, not an *equation*.

**equivalent** (adjective): Having the same value. For example, 4 quarters and 20 nickels are equivalent. Eight hours is equivalent to 28,800 seconds.  $4^3$  and 64 are equivalent.

**estimate** (verb): To make a rough guess at a number, usually without making written calculations

**evaluate** (verb): To calculate the value of something. If asked to *evaluate*  $4^3$ , your answer should be 64.

**expression** (noun): Numbers and symbols that show the value of something. 100,  $5x + 3$ , and  $2^3$  are all *expressions*.  $5x + 3 = 23$  is an equation made up of two *expressions*.

## Tools of Algebra: Nonlinear Functions (Part 1)

**exponent** (noun): In a quantity represented as a power, the *exponent* shows how many times the base is multiplied. The exponent is shown as a smaller number up and to the right of the base. For example, in the power  $2^3$ , the *exponent* is 3.

**exponential growth** (adjective): A growth pattern related to multiplying by a repeated factor.  $y = 2^x$  is a common example of an exponential function where 2 is used as a factor  $x$  times to calculate the output of  $y$ .

**factor** (noun): Whole numbers that are multiplied together to get another number. A number that can be divided into another number evenly, with no remainder.

**factor** (verb): To split a number into its factors (see above definition of factors).

**function** (noun): a relationship between two quantities. For every input into a function, there can only be one output. A function can be represented by an equation, a table, a graph, and a verbal or written description.

**generalize** (verb): To look at specific examples and realize that something is true *in general*. For example, what happens with you divide a number by itself? Specific examples:  $8 \div 8 = 1$  or  $25 \div 25 = 1$  or  $.75 \div .75 = 1$ . Example of a *generalization*: Any number divided by itself is 1.

**graph** (noun): A visual representation of a function relationship.

**input** (noun): The number that goes into a function.

**linear function** (noun): A function that has a constant rate of change. The graph of a linear function is a straight line.

**multiple** (noun): A number that can be divided by another number evenly, with no remainder. 25 is a *multiple* of 5.

**nonlinear function** (noun): A function that does not have a constant rate of change. The graph of a nonlinear function is not a straight line. There are many kinds of nonlinear functions. Two of them are *quadratic* functions and *exponential* functions.

**ordered pair** (noun): Ordered pairs are used to show a position on a graph. An ordered pair is made up of an input and an output that make a function true. They are usually written in parentheses like this (14, 7), where the first number shows the  $x$  value (horizontal) and the second number shows the  $y$  value (vertical).

**output** (noun): The value that comes out of a function when each input goes in. The output is dependent on the input.

**parabola** (noun): The shape of the graph of a quadratic function.

**pattern** (noun): Patterns are things we can observe. We gather information about what has come before to make predictions about what will come next.

**property** (noun): A character or quality that something has. In science, we use the physical property to refer to color, texture, density, and other qualities of physical objects. In mathematics, properties refer to characteristics of numbers or operations. Example:

*Commutative property:* Addition and multiplication are *commutative*, meaning the order of the operation doesn't matter.  $2 + 7 = 7 + 2$  and  $2 \cdot 7 = 7 \cdot 2$

**product** (noun): The result of multiplication. 4 times 5 gives a *product* of 20.

**quadratic growth** (noun): A growth pattern related to the size of different squares. A quadratic function in standard form looks like  $y = ax^2 + bx + c$  where  $a$  can be any number except 0. The  $x^2$  ( $x$  "squared") term in the equation makes the function quadratic.

**rate of change** (noun): The rate of change in the outputs when the inputs are consecutive. Known as *slope* when a part of the graph of an equation.

**root** (noun): A *root* is a value you can put into a function as an input for  $x$  so that 0 is an output for  $y$ . For example, the  $x$ -values -3 and -2 are the roots of the function  $y = (x + 2)(x - 3)$ . In a graph, the  $x$ -intercepts (points where a line intersects with the  $x$  axis) are the same as the *roots*. The word *zero* is sometimes used to mean the same thing as *root*. The roots,  $x$ -intercepts, and zeros (all which mean the same thing) are the solutions to a function equation.

*square root:* A square root of a number is a value that, when multiplied by itself, gives the number. The *square root* of 25 is 5.

**starting amount** (noun): The value of the output when the input is zero. Known as *y-intercept* when a part of the graph of an equation.

**term** (noun): A single number or variable, or numbers and variables multiplied together. Terms are separated by + or - signs. For example, there are three terms in the equation  $2 + 5 = 7$ .

## *Tools of Algebra: Nonlinear Functions (Part 1)*

**variable** (noun): A letter or symbol that represents another value, either any number, a specific number, or a set of numbers. In the expression  $x^3$ ,  $x$  is a *variable* that could mean any number. Variables can also represent other things. For example, in geometry, points and angles are represented by letters.

**vertex** (noun): The highest or lowest point on a parabola.

**x-axis**: The line that goes from left to right in a graph. The horizontal axis on the coordinate grid.

**x-intercept** (noun): The point of intersection with the  $x$ -axis of a graph.

**y-axis** (noun): The line that goes from top to bottom in a graph. The vertical axis on the coordinate grid.

**y-intercept** (noun): The point of intersection with the  $y$ -axis of a graph.


**zero-product property** (noun): This fact has to do with multiplication. If two numbers multiplied together gives a result of 0, then one of the two numbers must equal zero. It is also written this way: If  $a \cdot b = 0$ , then  $a$  or  $b$  has to be equal to 0.

## Using Graphic Organizers to Learn Vocabulary

In order to learn math vocabulary, we need practice using words in different ways. In this activity, you will choose a few words from this packet that you want to practice, then you will complete a graphic organizer for each word. Look at the sample for the word *quotient* below.


To start, choose a word from the packet and complete the graphic organizer:


