## Introduction to Rates

## What is a Rate?

A rate is a comparison between two related quantities. Here are a few examples of rates:

- When we go shopping, we can think about price per pound.
- When we talk about a pay rate, we can look at dollars per hour.
- When checking our heart rate, we can count heartbeats per minute.

We often use the word per when we are working with rates. The word per means for each or for every.

Speed is common rate that we encounter in our daily lives. When we drive, we measure our speed in miles per hour (mph). When we say we were driving 60 miles per hour, it means the car is traveling 60 miles for each hour of driving.

## Rate of Change and Starting Amount

## Introduction to Rate of Change

Functions allow us to analyze change. In this section you will learn about the rate of change of a function. The rate of change describes how fast (or how slow) something is changing. Rates of change can be found in tables, graphs, and equations.

Did you notice a pattern in the inputs and outputs for both functions?
The inputs for both functions go up by 1. The outputs of both functions go up by 2 .


The inputs increase by 1. In other words, they are consecutive. Consecutive numbers follow each in other in order without skipping. As the inputs increase by 1 , the outputs increase by 2. The rate of change for both of the functions above is 2 .

Core Concept: The rate of change is the constant change in the outputs when the inputs are consecutive.

The rate of change can be found in the table of a function by looking at the difference between the outputs as the inputs increase by 1.

The rate of change for a function can also be found in the function equation. If you look back at the equations, you'll notice that 2 appears in both of them.

$$
y=2 x+1 \quad y=2 x+4
$$

The rate of change in the equation is the number we multiply by the input. A number multiplied by a variable is called a coefficient. In the equations above, 2 is the coefficient of $x$. 2 is also the rate of change in both functions.

Both functions share an ordered pair: $(0,4)$. How is it possible for two functions with different rates of change to both have an output of 4 for an input of 0 ?

The clue is the input of 0 . When we multiply any number by 0 , the result is O . If we multiply an input of 0 by 5 or by 3 , the product will be 0 .


An input of $O$ knocks out the first part of the equation, leaving us to add 4 in both functions. So when a 0 goes in, a 4 comes out.

We call this value the starting amount. The starting amount for both of these functions is 4 .

## Core Concept: The starting amount is the value of the output when the input is zero.

## Rate of Change and Starting Amount in Graphs

The rate of change and starting amount of a function can also be observed in the graph of that function.

Finding the Rate of Change in Graphs

Consider the following situation:

Two friends, Sam and Chris, plan to race 15 blocks on their bicycles. Sam rides at a speed of 3 blocks per minute and Chris rides 5 blocks per minute.

Here is the graph of both functions. Each line represents one of the riders.

Here is the graph of the function for Chris' ride.

19) What do you notice?

Remember that the rate of change is the constant change in the outputs when the inputs are consecutive. In this function, the input is the number of minutes and the output is the number of blocks traveled.

The rate of change for the function of Chris' ride is 5 . The graph representing Chris' ride shows that for each minute that goes by, Chris travels 5 blocks. We can identify the rate of change from the graph of this function by looking at the change in the outputs as the inputs increase by 1.
20) The rate of change for the function of Sam's ride is 3 . In the graph of Sam's function below, show the rate of change.


Chris rides at a rate of 5 blocks per minute. If we want to know how many blocks Chris rides in a certain time period, we can multiply the number of minutes by 5 . For example, if Chris rides for 6 minutes, then Chris will travel 30 blocks. Since Sam rides 3 blocks for every minute, we can multiply the number of minutes Sam rides by 3 to figure out the number of blocks. For example, if Sam rides for 6 minutes, Sam will travel 18 blocks.


Both riders start at the same place. At 0 minutes, they have both traveled O blocks. After 1 minute of riding, Chris has traveled 5 blocks and Sam has traveled 3 blocks. After 1 minute, Chris is two blocks ahead of Sam.
21) After two minutes, how big is Chris' lead?
22) After three minutes, how long is Chris' lead?

Every minute that they race, Chris will continue to get further and further ahead of Sam. When we compare different linear functions on a graph, we can tell which one has a larger rate of change. A function with a larger rate of change means that it changes faster. In this bike example, the line representing Chris's ride is steeper than the line that represents Sam's ride. It is steeper because it is changing faster.

> Core Concept: The rate of change for any function is sometimes referred to as the slope. This is because the rate of change affects the steepness of the graph. The larger the slope, the steeper the line of the function will be. The rate of change of a function is the same thing as its slope.

## Finding the Starting Amount in Graphs

Remember that the starting amount is the value of the output when the input is zero. In the race between Chris and Sam, the input was the number of minutes and the output was the number of blocks traveled. In that race, the starting amount for both functions was O . Let's see what happens if they have a different starting amount.

After Chris wins their first race, Sam wants a head start, since Chris is the faster rider. Chris agrees to let Sam start 3 blocks closer to the finish line.

Who do you think will win the race?

Since the starting amount is the value of the output when the input is zero, the $x$ value of the starting amount is O .

When the input, or the $x$ value, of a function is 0 , the point will fall on the $y$-axis. The starting amount for a function is also known as the $y$-intercept because that is the point where the line of the function will cross the $y$-axis.


Core Concept: The starting amount of a function is sometimes called the $y$-intercept. This is because in the graph of a linear function, the starting amount is the point where the function intersects with the $y$-axis.

## Linear Functions with the Same Slope

In the example of Sam and Chris' bike race, you compared the graphs of two functions with different slopes (rates of change). The following functions have the same slope but different $y$-intercepts (starting amounts).

## Rate of Change and Starting Amount in Equations

The rate of change and starting amount can also be found in function equations.
Let's imagine we are going apple picking and we are trying to choose between two orchards: Redding Farm and Cooke Orchard.

Both orchards have a wide selection of quality apples.

- At Redding Farm, they charge $\$ 3.00$ for each pound of apples.
- At Cooke Orchard, they charge a $\$ 5.00$ entry fee and $\$ 2.00$ for each pound of apples.


At Redding Farm there is no entrance fee. The price is $\$ 3.00$ for each pound of apples you buy.

- If we buy 1 pound of apples, we pay $\$ 3$.
- If we buy 2 pounds of apples, we pay $\$ 6 \rightarrow \$ 3+\$ 3$
- If we buy 3 pounds of apples, we pay $\$ 9 \rightarrow \$ 3+\$ 3+\$ 3$
- If we buy 4 pounds of apples, we pay $\$ 12 \rightarrow \$ 3+\$ 3+\$ 3+\$ 3$

Here's another way to look at the cost of the first 4 pounds of apples at Redding Farm:

| 1 pound | $\underline{2 \text { pounds }}$ | 3 pounds | 4 pounds |
| :---: | :---: | :---: | :---: |
| $\$ 3$ | $\$ 3+\$ 3$ | $\$ 3+\$ 3+\$ 3$ | $\$ 3+\$ 3+\$ 3+\$ 3$ |
| $1 \times 3$ | + | 3 $\times 3$ | $4 \times 3$ |

The number of pounds changes depending on how many apples we buy, but the price per pound stays the same. It is always $\$ 3$ per pound. If we multiply the number of pounds by $\$ 3$, we get the total cost of apples.

We can write an equation with words to represent this relationship:

## The total cost = Multiply the number of pounds by 3

We can use variables to represent that same relationship:

$$
c=3 p
$$

where $c$ represents the total cost and $p$ represents the number of pounds of apples.

At Cooke Orchard, the cost is also determined by the number of pounds of apples you buy.
1pound

$1 \times 2$
2 pounds
3 pounds


But at Cooke Orchard there is also an entry fee of \$5.

Whatever number of pounds you put into the function, you are going to multiply that number by 2 and then add 5 .

$$
\begin{aligned}
& \text { If you buy } 20 \text { pounds of apples } \rightarrow 20(2)+5=\$ 45 \\
& \text { If you buy } 15 \text { pounds of apples } \rightarrow 15(2)+5=\$ 35 \\
& \text { If you buy } 100 \text { pounds of apples } \rightarrow 100(2)+5=\$ 205
\end{aligned}
$$

We can write an equation with words to represent this relationship: the total cost = multiply the number of pounds of apples by $2+\$ 5$ for the entry fee.

We can also use variables to represent the input and the output.

$$
c=2 p+5
$$

where $p$ represents the number of pounds of apples and $c$ represents the total cost.

Let's look at both function equations.


Cost per pound
(Rate of Change)

c=\frac{1}{3} p
$$

## Cooke Orchard



In the function equations for both orchards, the rate of change is the cost per pound. The starting amount is the entrance fee-for Redding Farm it is O and at Cooke Orchard it is 5.

## Functions in Our World

In this section, you will explore several real-world situations using linear functions. You will use the skills you have developed to explore temperature conversion, an electric bill, thunderstorms, and a model medical trial.

## Temperature

This table shows the highest recorded temperatures for several cities across New York State.

1) What do you notice?

One thing you might have noticed is that, for someone from the United States, the highest recorded temperatures in each of those cities seem very low! That is because the high temperatures are given in the temperature scale called Celsius. The way to write a temperature in Celsius is to write the measurement followed by ${ }^{\circ} \mathrm{C}$. The way we read $24^{\circ} \mathrm{C}$ is " 24 degrees Celsius."

The Celsius scale was developed around 1744 and is the measure of temperature used in every country in the world except for the United States, the Bahamas, Belize, the Cayman Islands, and Palau. Those countries use an older temperature scale called Fahrenheit. The Fahrenheit scale was created in 1724 by Daniel Gabriel Fahrenheit. Twenty-four degrees Fahrenheit would be abbreviated as $24^{\circ} \mathrm{F}$. The temperatures $24^{\circ} \mathrm{C}$ and $24^{\circ} \mathrm{F}$ are very different!

The table shows the highest temperatures for the same cities across New York State, given in Fahrenheit.

Most thermometers use both scales when displaying the temperature. We can make observations to learn about the relationship between Celsius and Fahrenheit.

2) Look closely at this thermometer. What do you notice?

One important thing to notice is that, for every temperature in Fahrenheit, there is an equivalent temperature in Celsius. For example, $10^{\circ} \mathrm{C}$ is the same temperature as $50^{\circ} \mathrm{F}$. There is one equivalent temperature in Fahrenheit for every temperature in Celsius.

You may be familiar with a few equivalent temperatures. For example, $0^{\circ} \mathrm{C}$ and $32^{\circ} \mathrm{F}$ are the same temperature. This is the temperature at which water freezes. $100^{\circ} \mathrm{C}$ and $212^{\circ} \mathrm{F}$ are another example of two temperatures that are equivalent. This is the temperature of boiling water ${ }^{1}$.

Let's take a look at some other equivalent temperatures.

Up to now, when we have looked at the rate of change in function tables, we have focused on consecutive inputs. But in this table, the inputs (the Celsius temperatures) are not consecutive since they go up by 10 instead of 1 .

Even when the inputs are not consecutive, we can still determine the rate of change. To see how this works, let's try making the inputs consecutive, by filling in the missing inputs and outputs.

In the table, we can see that O degrees Celsius is equivalent to 32 degrees Fahrenheit. And if the temperature in Celsius goes up by 10 degrees, the temperature in Fahrenheit goes up 18 degrees, from 32 to 50 degrees.

<Hint: If you start at 32 and go up by 1 degree, you won't reach 50. If you start at 32 and the outputs go up by 2 degrees, you will end up higher than 50.>

The approach below may remind you of the 0 to 70 number patterns you worked on in Tools of Algebra: Linear Functions, Part 1. To go from an output of 32 to an output of 50, we need to go up 18 degrees in total. The inputs increase by 10, so we have 10 "jumps" to go up 18.


So how big is each jump?
If we divide 18 up into 10 equal jumps, we get 1.8 for each jump.


We can use this strategy to find the rate of change in any function table, even if the inputs are not consecutive.

## Finding the Rate of Change when the Inputs are Not Consecutive

Step 1: Find the difference between two outputs. (This will tell you how much the outputs have changed.)

Step 2: Find the difference in the inputs. (This will tell you the number of "jumps") Step 3: Divide the difference between the outputs by the difference between the inputs.

## Electricity Bills

The monthly bills we receive for basic utilities like telephone, gas, and power often involve functions. For example, the electricity bill from your power company is calculated using a function rule. Here's an example of how your bill might look:

## Elektro Power

This month's electricity charges
These charges are based on a 30-day period of electricity usage. Your power usage is measured in the number of kilowatt hours (kWh) you used in the past month. For reference, one kWh powers a 10-watt light bulb for 100 hours.

We know that the electricity usage rate is $\$ 0.20 / \mathrm{kWh}$ (20 cents per kilowatt hour). This rate will be the same no matter how much electricity we use. We also know that the service charges of $\$ 18.00$ will be the same for different amounts of electricity usage.

The Electricity usage rate and Service charges are called constants since they don't change. The word constant means to stay the same. A constant companion is a friend who is always there for you. In mathematics, constants are the part of an equation that don't change when different numbers are substituted for the variables. In this situation, the constants stay the same for different amounts of electricity used.

We could rewrite the formula with the constants 0.20 and 18 included as numbers:

$$
\text { Total electricity charges }=\text { Electricity usage } \cdot 0.20+18
$$

Total electricity charges and Electricity usage are different for each electricity bill and are considered variables, since they vary or change. Usage charges also change with each bill, but isn't a separate variable since it is a combination of Electricity usage and Electricity usage rate .

For a simplified algebraic formula, let's use $c$ instead of Total electricity charges and replace Electricity usage with $u$ :

$$
c=0.20 u+18
$$

## The Speed of Light and the Speed of Sound

Have you ever looked up and seen a plane, only to hear the sound of the plane a minute or two later? This happens because light travels faster than sound. How much faster? Light travels at a rate of about 186,000 miles per second. Sound travels much slower. Sound travels at a rate of about 1 mile for every 5 seconds. We can observe the difference
 between the speed of light and the speed of sound in the world around us.

Thunder is the sound produced by lightning ${ }^{2}$, but you may have noticed that you can always see the lightning before you can hear the thunder. The delay between the lightning and the thunder happens because light from the lightning travels to your eyes faster than sound travels to your ears.

When you see a lightning bolt, you can figure out how far away it is by counting the seconds between when you see the lightning and when you hear the thunder. The farther away the storm, the more time there will be between seeing lightning and hearing the thunder.

1) Some things you may have noticed: Different cities across NY. It looks like a function table, but there are cities in the input column. The lowest temperature is $32^{\circ}$ and the highest is $41^{\circ}$. The temperatures are in a column labeled "Highest Recorded Temperature." These temperatures seem too low to be high temperatures.
2) Some things you may have noticed: The temperatures are in Fahrenheit on the left and Celsius on the right. The Celsius temperatures are labeled by 10 s and the Fahrenheit temperatures are labeled by 20s. There are numbers below 0 . The Fahrenheit temperatures go from $-40^{\circ}$ to $120^{\circ}$. The Celsius temperatures go from $-40^{\circ}$ to $50^{\circ}$. They both start at $-40^{\circ}$ but the Fahrenheit goes all the way up to $120^{\circ}$.
3) Some patterns you may have noticed: As the Celsius temperatures go up by 10 , the Fahrenheit temperatures go up by 18. The difference between each Celsius and its equivalent Fahrenheit is 8 more than the one before it (For example, The difference between 0 and 32 is 32 . The difference between 10 and 50 is 40 . The difference between 20 and 68 is 48 .) The ones digit in the Fahrenheit temperatures repeats the pattern $4,2,0,8,6,4,2,0,8,6, \ldots$

## Test Practice Questions - Answer Key

1. Part One: Choice A. This function is showing us the relationship between Samantha's profit and the number of cups of iced tea she sells. Her profit is a function of how many cups she sells. In the function $P(c)=.75 c-9.46$, the .75 represents the price of each cup of iced tea. Multiplying that number by $c$, the number of cups she sold, tells us the amount of money she made. Since profit is determined by taking the amount of money earned and subtracting the cost of what we produced, the 9.46 represents the $\$ 9.46$ it must have cost to make the iced tea.

Part Two: Choice B. In the function $P(c)=.75 c-9.46$, the .75 represents the price of each cup of iced tea. If Samantha raises the price of each cup by 50 cents, then the new price would be $\$ 1.25$.
2. Choice D . In the function $\mathrm{C}(m)=50 m+75$, the rate of change is 50 and the starting amount is 75 . We can think of the starting amount as a flat fee that we only pay once and we can think of the rate of change as a monthly cost. We can assume that the variable $m$ represents the number of months. If you put a 2 (for two months) into the function, you get $50(2)+75$, which is $\$ 175$. If you put a 3 in, you get $50(3)+75$, which is $\$ 225$. That reflects the written description in Choice D of paying $\$ 75$ to join and then $\$ 50$ each month.
3. Choice $\mathbf{C}$. The rate of change for this function is 16 . One way to calculate that is to look at the two consecutive inputs, 6 and 7. The change in the outputs between those two consecutive inputs is 16 . Evaluating all of the answer choices, choice C is the only one that does not equal 16 .
4. Choice C. Choice $B$ is a compelling answer choice because it has the correct rate of change ( 0.21 ) and the correct starting amount (0.50). A good strategy when you are given a written description to match an equation is to try a few numbers.

The function table on the right is the one that matches the written description of the function. The USPS charges 0.50 for a letter weighing up to 1 ounce.
5. Choice D. Making a quick table can also be helpful when you are asked to evaluate statements like this. The table below allows us to see that statements A, B, and C are all true. Since Melvin is adding $\$ 15$ a week the rate of change of the function describing his saving would be 15 . The rate of change for Alexis' saving is 5 , which is a smaller growth.

6. Choice $\mathbf{C}$ has an input of 3 and an output of 42 . The chart already has an output of 39 for an input of 3 . A function can not have the same input resulting in different outputs, therefore including $(3,42)$ in the table would mean that the table doesn't represent a function
7. Choice $\mathbf{D}$. A rate of 2 gallons per minute is equivalent to 32 cups of water per minute. If the rate is 32 cups per minute, it would be $32 \times 15$ or 480 cups of drinking water used in a 15 minute shower,
8. Choice $B$ is the only choice that does not have two different outputs for the same input.

9. Choice $\mathbf{A}$. The function gives the starting height of the tree as 36 inches, which is equivalent to 3 feet. Choice $B$ reverses the rate of change and the starting amount-you are likely to see this kind of misleading answer on the high school equivalency exam. Choices $C$ and $D$ are also common misleading answers. They are both almost true. Choice C is almost true - the tree does grow 51 inches in its first year, but the statement says it grows 51 inches each year, which is not true. Choice D is also almost true - in 5 years, the tree grows 111 inches, but the statement says every five years the tree grows 111 inches, which is not true.

The function describing Eddie's savings is $f(x)=20 x+4000$. The problem tells us that their accounts had the same amount of money after 10 months.

After ten months, Eddie has 2O(10) +4000 , which equals $\$ 6000$.

Brenda has been saving \$300 a month. After ten months, she will have saved $\$ 3000$. Since the problem tells us they had the same amount of money after the ten months, Brenda must have started with a starting amount of \$3000.

14. The numbers in this sequence are increasing by 3 . If the sequence continued until the 9 th term, the sequence would be $-12,-9,-6,-3,0,3,6,9,12$.

15. Choice A . The rate of change for the function represented by the graph is 0.5 or $1 / 2$. The rate of change for the function in the table is 0.25 . The rate of change on the table appears to be 0.5 , making Choice $C$ a compelling misleading choice. But the inputs in the table are not consecutive, they are going up by 2 .
16. Choice B. A $\$ 80$ flat fee charge plus a $\$ 40$ flat fee insurance charge would result in a starting amount of \$120.
17. The function equation that describes the relationship between the figure number and the number of squares in this sequence is $y=4 x+1$, where $x$ is the figure number and $y$ is the number of squares. The problem gives us the number of squares, so we can set up the equation $89=4 x+1$.

Another strategy is to think about thow the figure grows and ask what is changing and what is staying the same.


There is always 1 square in the middle. There are always 4 "arms" coming out of the center square. The number of squares in each arm is equal to the figure number. If we imagine 89 squares, we can put 1 in the middle, which leaves us with 88 squares, If we have 88 squares left and divide them into 4 equal groups, each group would have 22 squares. Figure 22 is the one that has 22 squares in each arm. $89=22+22+22+22+1$
18. Choice B. According to the table, when the input is zero, the output is 20 . That means we are looking for an equation with a starting amount of 20.
19. Choice C. Based on the graph, the starting amount of this function is 120 . That only matches one answer choice. Another strategy is to pick a point and put it into each answer choice. Point $(4,200)$ appears on the line of this function. 20(4) $+120=200$.
20. Choice D. Making a quick table for each situation allows you to see that only one has them does not have a constant rate of change.
21. Choice D. Be careful of Choice A. The difference in the outputs shown in the table is 4, but the inputs are not consecutive.
22. Choice B. A key feature of linear functions is a constant rate of change, even if the outputs are decreasing in value..
23. Choice A. Linear functions that have the same rate of change will have graphs that are parallel to each other.
24. Choice A. Usain Bolt won a gold medal in 2012 with a time of 9.63. Tom Burke won in 1896 with a time over 11 seconds.
25. Choice $B$ is the only choice with a constant rate of change.
26. Choice $C$. The rate of change for this function is 5 and the starting amount is 1 , so we can use the function $y=5 x+1$. When the input is 16 , the output is 81 .
27. Choice D. Since one of the ordered pairs given has an input of 5 and an output of 28, the function cannot have another solution with an input of 5 and an output of 19.
28. Choice B and Choice D. A table based on the points on the graph allows us to identify the rate of change (-50) and the starting amount (13)

29. Choice $B$. The hourly rate is the rate of change in the function. If her standard rate, $\$ 125$, is reduced by $\$ 35$, then her "Friends and Family" hourly rate would be $\$ 90$. The problem does not mention a discount in the house call fee.
30.Choice D. 1.8(15) $+32=59$
30. Choice D. The currency of the United States is the US dollar. When we talk about foreign currency, we are talking about the money that is used in other countries. We use exchange rates to determine the equivalent value between different currencies. There are different strategies you might use to answer a question like this. We are given inputs and outputs and possible rates of change. One method is to multiply each of the inputs by the given possible values of $m$ and see which one results in the given outputs. Another method might be to use the information in the table to determine the rate of change, looking at the change in the inputs and the change in the outputs.
31. Choice A, B, D. High altitude cooking is cooking that is done at altitudes well above sea level. The higher you go, the less air pressure there is. A decrease in air pressure causes a decrease in the temperature required to make water boil. So basically, the higher your altitude, the lower the boiling point of water!
32. Choice C. When answering questions like these, eliminating choices can help. We can tell by the function equation given that the function is linear, so we can eliminate choice B. Choice A can also be eliminated because it has a negative slope. The main difference between choices $C$ and $D$ are the $y$-intercepts. The function equation has a $y$-intercept of -2 , so we can eliminate choice $D$.
33. Choice A. Since the table already has an input of 4 with an output of 7 , having another input of 4 and an output of 13.75 would make this not a function.

## Vocabulary Review

You can use this section to look up words used in this math packet.
coefficient (noun): a number used to multiply a variable. In the linear equation $y=7 x+12,7$ is a coefficient. <see RATE OF CHANGE, SLOPE>
consecutive (adjective): Consecutive numbers are numbers that follow each other in order, without skipping, from smallest to largest. For example, 23, 24, 25, 26 are consecutive numbers.
coordinate plane (noun): a completely flat surface formed when two straight number lines go across each other at right angles. The point where the lines intersect is called the origin and represents the zero on each axis. An exact position on the grid can be described using coordinates. The coordinate plane is also called the coordinate grid. <see ORIGIN, X-AXIS, Y-AXIS>
constant (noun): A value in an expression or equation that doesn't change. For example, in the
 function $y=4 x+6$ the numbers 4 and 6 are both constants.
constant (adjective): Something that stays the same. A constant rate of growth means that the rate stays the same over time.
dependent variable (noun): The variable in a function that represents the output. <see INDEPENDENT VARIABLE>
domain (noun): the set of possible values for the independent variable. <see RANGE> equation (noun): A number sentence that shows two expressions are equal by using the equal sign.
evaluate (verb): to calculate the value of something.
function (noun): a relationship between two quantities. For every input into a function, there can only be one output. A function can be represented by an equation, a table, a graph, and a verbal or written description.
function notation (noun): a way of writing a function that emphasizes the relationship between the independent variable and the dependent variable used in the function. For example we can read $\mathrm{f}(\mathrm{x})=2 \mathrm{x}+5$ as "the function of x is $2 \mathrm{x}+5$."
graph (noun): a visual representation of a function relationship.
horizontal (adjective): going side to side. On the coordinate grid, the x -axis is horizontal.
independent variable (noun): The variable in a function that represents the input <see DEPENDENT VARIABLE>
input (noun): the number that goes into a function.
linear (adjective): linear means "a straight line". A Linear function is a function that grows in a constant way. The graph of a linear function is a straight line.
linear function (noun): A function that has a constant rate of change. The graph of a linear function is a straight line.
line of best fit / trend line (noun): a line on a graph that shows the general direction and trend that a set of points seem to follow. ssee SCATTER PLOT>
model (verb): In math, to model a real-world situation means to create a mathematical representation of that situation.
origin (noun): the point where the $x$-axis and the $y$-axis intersect on the coordinate grid. The origin has the coordinates ( 0,0 ).
ordered pair (noun): Ordered pairs are used to show a position on a graph. An ordered pair is made up of an input and an output that make a function true. They are usually written in parentheses like this $(14,7)$, where the first number shows the $x$ value (horizontal) and the second number shows the $y$ value (vertical). <see FUNCTION SOLUTIONS, COORDINATE GRID>
output (noun): the unique value that comes out of a function when each input goes in. The output is dependent on the input.
pattern (noun): Patterns are things we can observe. We gather information about what has come before to make predictions about what will come next.
parallel (adjective): parallel lines are lines on a plane that never meet. The graphs of linear functions that have the same slope are parallel. For example: The line graph of $y=4 x+3$ is parallel to the line graph of $y=4 x$
per (preposition): for each or for every

- The car was traveling 40 miles per hour.
- Most showers use 2.1 gallons of water per minute.
- The taxi charges $\$ 2.75$ per mile.
- The air pressure in your car tires should be 32-35 pounds per square inch.
plot (noun): to draw a point on the coordinate grid or a graph that represents an ordered pair. product (noun): the number you get from multiplying two or more numbers.
quantitative (adjective): something related to amounts or numbers.
quantity (noun): a measurement that is (or can be) specified by a number and a unit. For example 3 mangos, 16 feet, "the amount of money in a savings account", "the number of times a heart beats in a minute"
range (noun): the set of outputs for a function. the set of possible values for the dependent variable. <see DOMAIN>
rate (noun): A rate compares two different quantities.
- The sink was leaking at a rate of $1 / 2$ an ounce of water per minute
- The train traveled at 80 miles per hour. For every hour, the train traveled 80 miles.
- The hybrid car gets a gas mileage rate of 50 miles per gallon. For every 1 gallon of gas, the car can travel 50 miles.
rate of change (noun): the rate of change in the outputs when the inputs are consecutive. <see SLOPE>
scatterplot (noun): A graph of plotted points that show the relationship between two sets of data. <see LINE of BEST FIT>
sequence (noun): a list of numbers, objects, or events in a special order.

slope (noun): Slope refers to how steep a line is. The slope of a line is also known as the rate of change. The slope is how the rate of change <see RATE of CHANGE>
solution (noun): A solution to a function is any ordered pair ( $x, y$ ) that can be used to make a function equation true. For example, $(3,14)$ and $(4,18)$ are both solutions to the function $y=4 x+2$ because if you an input of 3 results in an output of 14 and an input of 4 results in an output of 18 .
starting amount (noun): the value of the output when the input is zero. <see $Y$-INTERCEPT> table (noun): information arranged in rows and columns. A function table can be used to list some of the input and output values for a function.
term (noun): Term is used to describe where a number is in a pattern. The first number in a pattern is Term 1 , the second number is Term 2 , and so on. Term 8 would be the eighth number in a pattern.
variable (noun): A letter or symbol that represents another value, either any number, a specific number, or a set of numbers.
vertical (adjective): Going up and down. On the coordinate grid, the $y$-axis is vertical. $\mathbf{x}$-axis (noun): the line that goes from left to right in a graph. The horizontal axis on the coordinate grid.
x-intercept (noun): the point where a line crosses the $x$-axis of a graph.
$y$-axis (noun): the line that goes from top to bottom of a graph. The vertical axis on the coordinate grid.
$y$-intercept (noun): the point where a line crosses the $y$-axis of a graph. <see STARTING AMOUNT>
